PERMIT TO APPROPRIATE THE PUBLIC WATERS

This is to certify that I have examined APPLICATION 61227 and do hereby grant the same SUBJECT TO EXISTING RIGHTS INCLUDING THE APPROPRIATE MINIMUM FLOW POLICIES ESTABLISHED BY THE WATER POLICY REVIEW BOARD and the following limitations and conditions:

This permit is issued to Robert F. Forte of Route 1, Box 113, Halfway, OR 97834, phone 742-2257, for the use of the waters of three unnamed draws, being 0.1 cubic foot per second from Draw 1, 0.18 cfs from Draw 2, and 0.12 cfs from Draw 3, tributaries of Pine Creek, for the PURPOSE of supplemental irrigation; that the PRIORITY OF THE RIGHT dates from February 4, 1981, and is limited to the amount of water which can be applied to beneficial use and shall not exceed 0.4 cfs measured at the point of diversion from the stream, or its equivalent in case of rotation with other water users.

The POINTS OF DIVERSION are to be LOCATED: <u>Draw 1 - 250</u> feet East; <u>Draw 2 - 550</u> feet East; <u>Draw 3 - 1,000</u> feet East, all from the Center of Section 30, being within the NW 1/4 SE 1/4 of Section 30, Township 7 South, Range 46 East, WM, in the County of Baker.

A description of the PLACE OF USE under the permit, and to which such right is appurtenant, is as follows:

Township 7 South Range 46 East, WM Section 30 NW 1/4 SE 1/4 Draw 1 - 4.0 acres NW 1/4 SE 1/4 Draw 2 - 7.0 acres NW 1/4 SE 1/4 Draw 3 - 5.0 acres

The AMOUNT OF WATER used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to 1/40 of one cubic foot per second per acre, from direct flow and shall be further limited to a diversion of not to exceed 4.5 acre-feet per acre for each acre irrigated during the irrigation season of each year, provided further that the right allowed herein shall be limited to any deficiency in the available supply of any prior right existing for the same land and shall not exceed the limitation allowed herein, and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

Actual construction work shall begin on or before April 8, 1983 and shall thereafter be prosecuted with reasonable diligence and be completed on or before October 1, 1984.

Complete application of the water to the proposed use shall be made on or before October I_{\bullet} 1985.
