**PERMIT TO APPROPRIATE THE PUBLIC WATERS**

This is to certify that I have examined APPLICATION 61298 and do hereby grant the same SUBJECT TO EXISTING RIGHTS INCLUDING THE APPROPRIATE MINIMUM FLOW POLICIES ESTABLISHED BY THE WATER POLICY REVIEW BOARD and the following limitations and conditions:

This permit is issued to R.S. and Evelyn Lynn of Sitkum Route, Box 111, Myrtle Point, OR 97458, phone 572-3619, for the use of the waters of East Fork Coquille River, a spring, and an unnamed stream, tributaries of North Fork Coquille River, for the PURPOSE of irrigation and domestic use for one family, being 0.025 cubic foot per second from East Fork Coquille River for irrigation, and 0.005 cfs from the spring with any deficiency in supply at the spring to be made up by diversion of water from the unnamed stream for domestic use; that the PRIORITY OF THE RIGHT dates from March 2, 1981, and is limited to the amount of water which can be applied to beneficial use and shall not exceed 0.03 cfs measured at the point of diversion from the stream, or its equivalent in case of rotation with other water users.

The POINTS OF DIVERSION are to be LOCATED: Spring - 1,650 feet West and 1,010 feet North; Unnamed Stream - 1,560 feet West and 835 feet North; East Fork Coquille River - 1,100 feet West and 2,620 feet North, all from the Southeast Corner of the SW 1/4 NE 1/4 of Section 13, being within: Spring and Unnamed Stream - SE 1/4 NW 1/4; East Fork Coquille River - NW 1/4 NE 1/4 of Section 13, Township 28 South, Range 11 West, WM, in the County of Coos.

A description of the PLACE OF USE under the permit, and to which such right is appurtenant, is as follows:

Township 28 South Range 11 West, WM Section 13 NW 1/4 NE 1/4 Domestic use for one family from the spring with any deficiency to be made up from the unnamed stream and 2.0 acres irrigation from East Fork Coquille River

The AMOUNT OF WATER used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to 1/80 of one cubic foot per second per acre, from direct flow and shall be further limited to a diversion of not to exceed 2.5 acre-feet per acre for each acre irrigated during the irrigation season of each year, and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

Actual construction work shall begin on or before April 8, 1983 and shall thereafter be prosecuted with reasonable diligence and be completed on or before October 1, 1984.

Complete application of the water to the proposed use shall be made on or before October 1, 1985.
