## PERMIT TO APPROPRIATE THE PUBLIC WATERS

This is to certify that I have examined APPLICATION 60712 and do hereby grant the same SUBJECT TO EXISTING RIGHTS INCLUDING THE APPROPRIATE MINIMUM FLOW POLICIES ESTABLISHED BY THE WATER POLICY REVIEW BOARD and the following limitations and conditions:

This permit is issued to Donald H. and Reha C. Giles of Route 1, Box 13-A, Harper, Oregon 97906, phone 358-2584, for the use of the waters of one continuous outcrop of water, for the PURPOSE of irrigation and supplemental irrigation, domestic use for one family and stock, being 22.54 gallons per minute for irrigation, 0.21 gpm for stock, and 0.25 gpm for domestic use; that the PRIORITY OF THE RIGHT dates from September 17, 1980, and is limited to the amount of water which can be applied to beneficial use and shall not exceed 23.0 gpm measured at the point of diversion from the stream, or its equivalent in case of rotation with other water users.

The POINTS OF DIVERSION are to be LOCATED: Diversion 1 - 280 feet South and 640 feet East; Diversion 2 - 360 feet South and 635 feet East; Diversion 3 - 465 feet South and 645 feet East; all from the N 1/4 Corner of Section 25, being within the NW 1/4 NE 1/4 of Section 25, Township 19 South, Range 42 East, WM, in the County of Malheur.

A description of the PLACE OF USE under the permit, and to which such right is appurtenant, is as follows:

Township 19 South Range 42 East, WM Section 25 NW 1/4 NE 1/4 Stock use from Diversion 1, domestic use for one family from Diversion 2, primary irrigation of 0.73 acres and 2.0 acres supplemental irrigation from Diversion 3

The AMOUNT OF WATER used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to 1/40 of one cubic foot per second per acre, from direct flow and shall be further limited to a diversion of not to exceed 3.0 acre-feet per acre for each acre irrigated during the irrigation season of each year, provided further that the right allowed herein shall be limited to any deficiency in the available supply of any prior right existing for the same land and shall not exceed the limitation allowed herein, and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

Actual construction work shall begin on or before April 12, 1983 and shall thereafter be prosecuted with reasonable diligence and be completed on or before October 1, 1984.

Complete application of the water to the proposed use shall be made on or before October 1, 1985.
