PERMIT TO APPROPRIATE THE PUBLIC WATERS

This is to certify that I have examined APPLICATION 60229 and do hereby grant the same SUBJECT TO EXISTING RIGHTS INCLUDING THE APPROPRIATE MINIMUM FLOW POLICIES ESTABLISHED BY THE WATER POLICY REVIEW BOARD and the following limitations and conditions:

This permit is issued to Paul G. Wares of Medical Springs Stage, Baker, Oregon 97814, for the use of the waters of Big Creek, an unnamed stream and reservoir to be appropriated under Application R-61437, Permit R-8361, for the PURPOSE of irrigation and supplemental irrigation; that the PRIORITY OF THE RIGHT dates from August 5, 1981, and is limited to the amount of water which can be applied to beneficial use and shall not exceed 3.62 cubic feet per second, being 2.35 cfs from Big Creek when available with any deficiency in the available supply from Big Creek to be made up by appropriation from the unnamed stream and reservoir for irrigation and 1.27 cfs from the unnamed stream and reservoir for supplemental irrigation, measured at the point of diversion from the stream, or its equivalent in case of rotation with other water users.

The POINTS OF DIVERSION are to be LOCATED: Diversion 1 - 53 degrees 45 minutes West 16.5 chains from the Northeast Corner of Section 28, being within the NE 1/4 NE 1/4 of Section 28, Township 6 South, Range 42 East, WM; Diversion 3 - 800 feet South and 0.0 foot West from the Northeast Corner of the NW 1/4 NW 1/4 of Section 24, being within the NW 1/4 NW 1/4 of Section 24, Township 7 South, Range 41 East, WM, in the Counties of Union and Baker.

A description of the PLACE OF USE under the permit, and to which such right is appurtenant, is as follows:

Primary

The AMOUNT OF WATER used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to 1/40 of one cubic foot per second per acre, from direct flow and shall be further limited to a diversion of not to exceed 3.5 acre-feet per acre for each acre irrigated during the irrigation season of each year, provided further that the right allowed herein shall be limited to any deficiency in the available supply of any prior right existing for the same land and shall not exceed the limitation allowed herein, and shall conform to such reasonable rotation system as may be ordered by the proper state officer.
