PERMIT TO APPROPRIATE THE PUBLIC WATERS

This is to certify that I have examined APPLICATION 61457 and do hereby grant the same SUBJECT TO EXISTING RIGHTS INCLUDING THE APPROPRIATE MINIMUM FLOW POLICIES ESTABLISHED BY THE WATER POLICY REVIEW BOARD and the following limitations and conditions:

This permit is issued to John F. Walchli of Route 3, Box 3342, Hermiston, Oregon 97838, phone 567-5842, for the use of the waters of Walchli Reservoir constructed under Permit R-6575 and to be enlarged under Application R-61456, Permit R-8362, for the PURPOSE of supplemental irrigation; that the PRIORITY OF THE RIGHT dates from March 27, 1981, and is limited to the amount of water which can be applied to beneficial use and shall not exceed 39.7 acre-feet stored water only.

The POINT OF DIVERSION is to be LOCATED: 1,040 feet North and 1,540 feet West from the E 1/4 Corner of Section 4, being within the SW 1/4 NE 1/4 of Section 4, Township 4 North, Range 29 East, WM, in the County of Umatilla.

The AMOUNT OF WATER used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to a diversion of not to exceed 4.5 acre-feet per acre for each acre irrigated during the irrigation season of each year, from reservoir constructed under Permit R-6575 and from reservoir to be enlarged under Permit R-8362, provided further that the right allowed herein shall be limited to any deficiency in the available supply of any prior right existing for the same land and shall not exceed the limitation allowed herein.

Actual construction work shall begin on or before April 29, 1983 and shall thereafter be prosecuted with reasonable diligence and be completed on or before October 1, 1984.

Complete application of the water to the proposed use shall be made on or before October 1, 1985.
