PERMIT TO APPROPRIATE THE PUBLIC WATERS

This is to certify that I have examined APPLICATION 61252 and do hereby grant the same SUBJECT TO EXISTING RIGHTS INCLUDING THE APPROPRIATE MINIMUM FLOW POLICIES ESTABLISHED BY THE WATER POLICY REVIEW BOARD and the following limitations and conditions:

This permit is issued to George H. Goodell of 1562 Sleepy Hollow Loop of Grants Pass, Oregon 97526, phone 476-8701, for the use of the waters of Applegate River and Applegate Lake Reservoir constructed under Application R-57600, Permit R-7810, tributaries of Rogue River, for the PURPOSE of irrigation and supplemental irrigation, being 0.04 cubic foot per second of water for irrigation from Applegate River and 3.0 acre-feet stored water only for supplemental irrigation from Applegate Lake Reservoir; that the PRIORITY OF THE RIGHT dates from February 13, 1981 for 0.03 cfs and March 4, 1982 for 0.01 cfs and 3.0 acre-feet, and is limited to the amount of water which can be applied to beneficial use and shall not exceed 0.04 cfs and 3.0 acre-feet stored water only measured at the point of diversion from the stream, or its equivalent in case of rotation with other water users.

The POINTS OF DIVERSION are to be LOCATED: Diversion 1 (Applegate River) - 750 feet North and 850 feet East from the Southwest Corner of Section 5, being within the SW 1/4 SW 1/4 of Section 5, Township 37 South, Range 6 West, WM; Applegate Lake Dam is located in the S 1/2 SE 1/4 of Section 25, Township 40 South, Range 4 West, WM, in the County of Josephine.

A description of the PLACE OF USE under the permit, and to which such right is appurtenant, is as follows:

Township 37 South Range 6 West, WM Section 5 SW 1/4 SW 1/4 3.0 acres

The AMOUNT OF WATER used for irrigation, together with the amount secured under any other right existing for the same lands, from direct flow and shall be further limited to a diversion of not to exceed 4.5 acre-feet per acre for each acre irrigated during the irrigation season of each year, provided further that the right allowed herein shall be limited to any deficiency in the available supply of any prior right existing for the same land and shall not exceed the limitation allowed herein, and is subject to the terms and conditions of Contract 1-07-10-W0343 between the Bureau of Reclamation and the applicant, or a satisfactory replacement, a copy of which is on file in the records of the Water Resources Director, and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

Actual construction work shall begin on or before May 11, 1983 and shall thereafter be prosecuted with reasonable diligence and be completed on or before October 1, 1984.

Complete application of the water to the proposed use shall be made on or before October 1, 1985.
