PERMIT TO APPROPRIATE THE PUBLIC WATERS

This is to certify that I have examined APPLICATION 57999 and do hereby grant the same SUBJECT TO EXISTING RIGHTS INCLUDING THE APPROPRIATE MINIMUM FLOW POLICIES ESTABLISHED BY THE WATER POLICY REVIEW BOARD and the following limitations and conditions:

This permit is issued to John Madison, of Route 1, Box 35, Echo, Oregon 97826, Agent for Frank N. Mueller, Top Cut Feedlots, Inc. by Brent Horn, Lowell Saylor, John Madison, Madison Ranches, Inc. by Gaylord Madison, Frank Pedro, Clausie H. Ammon by Bob Hale, Douglas Hale, Glenn Cochran, Jerry Myers, Mike McCarty, Ed Johnson, Frank Mader, Bob Hawkins, Bud Graham, Edward Burl Wattenburger, Jr., Earl W. Wattenburger by Eldon Witherrite, Leo Ashbeck, John B. Correa, Sidney R. Britt and Mabel Vey, for the use of the waters of Butter Creek, a tributary of Umatilla River, for the PURPOSE of supplemental irrigation. The use allowed herein may be made at any time between September 2 and December 30 of each year that water can be put to beneficial use by irrigation, either for immediate crop growth or for forecast requirements to raise soil moisture to field capacity in the soil profile to be utilized by plant growth in the subsequent growing season, that the PRIORITY OF THE RIGHT dates from October 16, 1978, and is limited to the amount of water which can be applied to beneficial use and shall not exceed 108.7 cubic feet per second measured at the point of diversion from the stream, or its equivalent in case of rotation with other water users.

The AMOUNT OF WATER used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to $\frac{1}{50}$ of one cubic foot per second per acre, from direct flow and shall be further limited to a diversion of not to exceed 1.0 acre-foot per acre for each acre irrigated during the period from September 2 to December 30, provided further that the right allowed herein, together with the amount secured under any other right existing for the same lands shall not exceed 4.0 acre-feet for each acre irrigated in any one year. The use of water authorized herein shall not establish priority of right as against future appropriations of surface water for beneficial uses or for storage for such beneficial uses, other than similar rights for irrigation from September 2 to December 30, and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

Actual construction work shall begin on or before May 19, 1983 and shall thereafter be prosecuted with reasonable diligence and be completed on or before October 1, 1984.

Complete application of the water to the proposed use shall be made on or before October 1, 1985.
