PERMIT TO APPROPRIATE THE PUBLIC WATERS

This is to certify that I have examined APPLICATION 60399 and do hereby grant the same SUBJECT TO EXISTING RIGHTS INCLUDING THE APPROPRIATE MINIMUM FLOW POLICIES ESTABLISHED BY THE WATER POLICY REVIEW BOARD and the following limitations and conditions:

This permit is issued to Myron L. and Judith A. Steward of PO Box 762, Lakeview, Oregon 97630, phone 947-3800, for the use of the waters of an unnamed drainageway, a tributary of Thomas Creek, for the PURPOSE of irrigation and supplemental irrigation; that the PRIORITY OF THE RIGHT dates from July 24, 1980, and is limited to the amount of water which can be applied to beneficial use and shall not exceed 0.96 cubic foot per second measured at the point of diversion from the stream, or its equivalent in case of rotation with other water users.

The POINT OF DIVERSION is to be LOCATED: 1,120 feet South and 600 feet East from the Center of Section 23, being within the NW 1/4 SE 1/4 of Section 23, Township 39 South, Range 19 East, WM, in the County of Lake.

A description of the PLACE OF USE under the permit, and to which such right is appurtenant, is as follows:

The AMOUNT OF WATER used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to 1/40 of one cubic foot per second per acre, from direct flow and shall be further limited to a diversion of not to exceed 2.5 acre-feet per acre for each acre irrigated during the irrigation season of each year, provided further that the right allowed herein shall be limited to any deficiency in the available supply of any prior right existing for the same land and shall not exceed the limitation allowed herein, and further provided that the right allowed herein shall be subject to the terms of a stipulation recorded at page 960, Volume 6, Miscellaneous Records of the Water Resources Director, and by reference made a part of this permit, and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

Actual construction work shall begin on or before May 19, 1983 and shall thereafter be prosecuted with reasonable diligence and be completed on or before October 1, 1984.

Complete application of the water to the proposed use shall be made on or before October 1, 1985.
