PERMIT TO APPROPRIATE THE PUBLIC WATERS

This is to certify that I have examined APPLICATION 62385 and do hereby grant the same SUBJECT TO EXISTING RIGHTS INCLUDING THE APPROPRIATE MINIMUM FLOW POLICIES ESTABLISHED BY THE WATER POLICY REVIEW BOARD and the following limitations and conditions:

This permit is issued to Milton Hill of 8174 North Applegate Road, Grants Pass, Oregon 97526, phone 862-2081, for the use of the waters of Applegate Lake Reservoir constructed under Permit R-7810, for the PURPOSE of supplemental irrigation; that the PRIORITY OF THE RIGHT dates from August 24, 1981, and is limited to the amount of water which can be applied to beneficial use and shall not exceed 40.0 acre-feet stored water only.

The POINT OF DIVERSION is to be LOCATED: 50 feet South and 50 feet East from the Northeast Corner of the SE 1/4 SE 1/4 of Section 27, being within the SW 1/4 SE 1/4 of Section 27, Township 37 South, Range 5 West, WM, in the County of Josephine.

Applegate dam is located in the S 1/2 SE 1/4 of Section 25, Township 40 South, Range 4 West, WM.

A description of the PLACE OF USE under the permit, and to which such right is appurtenant, is as follows:

The AMOUNT OF WATER used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to 4.5 acre-feet stored water only, and shall be further limited to a diversion of not to exceed 4.5 acre-feet per acre for each acre irrigated during the irrigation season of each year, provided further that the right allowed herein shall be limited to any deficiency in the available supply of any prior right existing for the same land and shall not exceed the limitation allowed herein, and is subject to the terms and conditions of Contact 1-07-10-W0403 between the Bureau of Reclamation and the applicant, or a satisfactory replacement, a copy of which is on file in the records of the Water Resources Director.

Actual construction work shall begin on or before May 19, 1983 and shall thereafter be prosecuted with reasonable diligence and be completed on or before October 1, 1984.

Complete application of the water to the proposed use shall be made on or before October 1, 1985.
