## PERMIT TO APPROPRIATE THE PUBLIC WATERS

This is to certify that I have examined APPLICATION 60259 and do hereby grant the same SUBJECT TO EXISTING RIGHTS INCLUDING THE APPROPRIATE MINIMUM FLOW POLICIES ESTABLISHED BY THE WATER POLICY REVIEW BOARD and the following limitations and conditions:

This permit is issued to Lowell Richard Ross of Box 173, Wolf Creek, Oregon 97497, for the use of the waters of a spring when available with any deficiency in supply from the spring to be made up by appropriation from a natural spring fed pond and an unnamed creek, tributaries of Coyote Creek, for the PURPOSE of mining and domestic use for one family including irrigation of not to exceed one-half acre lawn and noncommercial garden, being 0.015 cubic foot per second of water for mining and 0.005 cfs for domestic use; that the PRIORITY OF THE RIGHT dates from March 17, 1982, and is limited to the amount of water which can be applied to beneficial use and shall not exceed 0.02 cfs measured at the point of diversion from the stream, or its equivalent in case of rotation with other water users.

The POINTS OF DIVERSION are to be LOCATED: Diversion 1 (Spring 1) - 100 feet North and 1,200 feet West from the Southeast Corner of Section 28, being within the SE 1/4 SE 1/4 of Section 28; Diversion 2 (Spring fed Pond 2) - 960 feet North and 325 feet East from the Southwest Corner of Section 27, being within the SW 1/4 SW 1/4 of Section 27; Diversion 3 (Stream Diversion 3) - 50 feet North and 1,800 feet East from the Southwest Corner of Section 27, being within the SE 1/4 SW 1/4 of Section 27; Diversion 4 (Stream Diversion 4) - 275 feet North and 700 feet East from the Southwest Corner of Section 27, being within the SW 1/4 SW 1/4 of Section 27; all within Township 33 South, Range 5 West, WM, in the County of Josephine.

A description of the PLACE OF USE under the permit, and to which such right is appurtenant, is as follows:

Township 33 South Range 5 West, WM Section 27 SW 1/4 SW 1/4 Section 28 SE 1/4 SE 1/4

Mining
Mining and domestic
use for one family
including irrigation
of not to exceed onehalf acre lawn and noncommercial garden

This permit is issued subject to the maintenance and use of adequate treatment facilities to remove the sediment before returning the water to the stream.

Actual construction work shall begin on or before May 25, 1983 and shall thereafter be prosecuted with reasonable diligence and be completed on or before October 1, 1984.

Complete application of the water to the proposed use shall be made on or before October 1, 1985.
