PERMIT TO APPROPRIATE THE PUBLIC WATERS

This is to certify that I have examined APPLICATION 61943 and do hereby grant the same SUBJECT TO EXISTING RIGHTS INCLUDING THE APPROPRIATE MINIMUM FLUW POLICIES ESTABLISHED BY THE WATER POLICY REVIEW BOARD and the following limitations and conditions:

This permit is issued to Dennis Schiedler of 670 Alder Street, Mt. Angel, Oregon 97362, phone 845-6271, for the use of the waters of an unnamed stream and reservoir constructed under Permit R-3290, and Abiqua Creek, being 0.84 cubic foot per second of water from unnamed stream and reservoir, and 0.65 cfs from Abiqua Creek, tributaries of Pudding River, for the PURPOSE of irrigation and supplemental irrigation, being 0.85 cfs for irrigation from the unnamed stream with any deficiency to be supplied by Abiqua Creek and reservoir, and 0.65 cfs for supplemental irrigation from Abiqua Creek; that the PRIORITY OF THE RIGHT dates from April 12, 1982, and is limited to the amount of water which can be applied to beneficial use and shall not exceed 1.49 cfs measured at the point of diversion from the stream, or its equivalent in case of rotation with other water users.

The POINTS OF DIVERSION are to be LOCATED: Diversion 1 - 360 feet South and 860 feet East from the Northwest Corner of Section 22, being within the NW 1/4 NW 1/4; Diversion 2 - 1,420 feet North and 1,100 feet West from the Southeast Corner of the SW 1/4 SE 1/4 of Section 22, being within the NW 1/4 SE 1/4, both of Section 22, Township 6 South, Range 1 West, WM, in the County of Marion.

A description of the PLACE OF USE under the permit, and to which such right is appurtenant, is as follows:

The AMOUNT OF WATER used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to 1/80 of one cubic foot per second per scre, from direct flow and shall be further limited to a diversion of not to exceed 2.5 acre-feet per scre for each acre irrigated during the irrigation season of each year from direct flow and storage from reservoir to be constructed under Permit R-3290, provided further that the right allowed herein shall be limited to any deficiency in the available supply of any prior right existing for the same land and shall not exceed the limitation ellowed herein, and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

Actual construction work shall begin on or before May 25, 1983 and shall thereafter be prosecuted with reasonable diligence and be completed on or before October 1, 1984.

Complete application of the water to the proposed use shall be made on or before October 1, 1985.
