PERMIT TO APPROPRIATE THE PUBLIC WATERS

This is to certify that I have examined APPLICATION 61153 and do hereby grant the same SUBJECT TO EXISTING RIGHTS INCLUDING THE APPROPRIATE MINIMUM FLOW POLICIES ESTABLISHED BY THE WATER POLICY REVIEW BOARD and the following limitations and conditions:

This permit is issued to Stephen Marco Long and Nancy Elizabeth Brunner of 1481 Pine Ridge Drive, Glide, Oregon 97443, for the use of the waters of an unnamed stream, spring and reservoir to be constructed under Application R-61152, Permit R-8387, tributaries of Little River, for the PURPOSE of irrigation, supplemental irrigation and domestic use for one family being 0.044 cubic foot of water per second for irrigation from the unnamed stream; 0.002 cfs for supplemental irrigation from the spring; 0.005 cfs for domestic use for one family from the unnamed stream; and 0.02 acre-foot stored water only for supplemental irrigation from the reservoir, that the PRIORITIES OF THE RIGHT date from January 15, 1981 for 0.02 acre-foot and 0.049 cfs and March 9, 1982 for 0.002 cfs, and is limited to the amount of water, which can be applied to beneficial use and shall not exceed 0.051 cfs measured at the points of diversion from the streams and 0.02 acre-foot stored water only from the reservoir, or their equivalent in case of rotation with other water users.

The POINTS OF DIVERSION are to be LOCATED: Diversion 1 (Unnamed Stream) - 600 feet North and 200 feet East from the S1/4 Corner of Section 33, being within the SW 1/4 SE 1/4 of Section 33; Diversion 2 (Spring) - 860 feet South and 175 feet West from the Center Guarter Corner of Section 33, being within the NE 1/4 SW 1/4 of Section 33; and Diversion 3 (Reservoir) - 670 feet South and 260 feet West from the Center Guarter Corner of Section 33, being within the NE 1/4 SW 1/4 of Section 33, all being within Township 26 South, Range 3 West, WM, in the County of Douglas.

A description of the PLACE OF USE under the permit, and to which such right is appurtenant, is as follows:

Township 26 South Range 3 West, WM Section 33 NW 1/4 SE 1/4

Primary Irrigation
SE 1/4 1.5 acres and

domestic use for one family

NE 1/4 SW 1/4 2.0 acres

NE 1/4 SW 1/4 0.15 scre from the

spring and 1.85 acres from the reservoir

The AMOUNT OF WATER used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to 1/80 of one cubic foot per second per acre, from direct flow and shall be further limited to a diversion of not to exceed 2.5 acre-feet per acre for each acre irrigated during the irrigation season of each year, provided further that the right allowed herein shall be limited to any deficiency in the available supply of any prior right existing for the same land and shall not exceed the limitation allowed herein, and shall conform to such reasonable rotation system as may be ordered by the proper state officer.
