PERMIT TO APPROPRIATE THE PUBLIC WATERS

This is to certify that I have examined APPLICATION 62959 and do hereby grant the same SUBJECT TO EXISTING RIGHTS INCLUDING THE APPROPRIATE MINIMUM FLOW POLICIES ESTABLISHED BY THE WATER POLICY REVIEW BOARD and the following limitations and conditions:

This permit is issued to Jack E. and Leona M. Cook of Route 2, Box 1081, Bandon, Oregon 97411, phone 347-9726, for the use of the waters of a spring and an unnamed stream, tributaries of Coquille River, for the PURPOSE of domestic use for one family and irrigation, being 0.005 cubic foot per second of water for domestic use for one family, and 0.005 cfs for irrigation; that the PRIORITY OF THE RIGHT dates from October 9, 1981, and is limited to the amount of water which can be applied to beneficial use and shall not exceed 0.01 cfs measured at the points of diversion from the stream, or its equivalent in case of rotation with other water users.

The POINTS OF DIVERSION are to be LOCATED: <u>Diversion I (Spring)</u> - 1,340 feet South and 850 feet West; <u>Diversion 2 (Unnamed Stream)</u> - 1,270 feet South and 960 feet West, both from the N I/4 Corner of Section 16, being within the NE I/4 NW I/4 of Section 16, Township 28 South, Range 14 West, WM, in the County of Coos.

A description of the PLACE OF USE under the permit, and to which such right is appurtenant, is as follows:

Township 28 South Range 14 West, WM Section 16 NE 1/4 NW 1/4 Domestic use for one family from the spring and irrigation of 0.5 acre from unnamed

The AMOUNT OF WATER used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to 1/80 of one cubic foot per second per acre, from direct flow and shall be further limited to a diversion of not to exceed 2.5 acre-feet per acre for each acre irrigated during the irrigation season of each year, and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

Actual construction work shall begin on or before June 17, 1983 and shall thereafter be prosecuted with reasonable diligence and be completed on or before October 1, 1984.

Complete application of the water to the proposed use shall be made on or before October 1, 1985.
