PERMIT TO APPROPRIATE THE PUBLIC WATERS

This is to certify that I have examined APPLICATION 62122 and do hereby grant the same SUBJECT TO EXISTING RIGHTS INCLUDING THE APPROPRIATE MINIMUM FLOW POLICIES ESTABLISHED BY THE WATER POLICY REVIEW BOARD and the following limitations and conditions:

This permit is issued to Darrell Henry Green of box 30, Weaver Road, Myrtle Creek, Oregon 97457, phone 863-5013, for the use of the waters of two unnamed streams and two reservoirs to be constructed under Application R-62121, Permit R-8401 with any deficiency in the available supply from the two unnamed streams to be made up by diversion from South Umpqua River, being 0.13 cubic foot of water per second from Unnamed Stream 1 and 0.045 cfs from Unnamed Stream 2, for the PURPOSE of irrigation and stock water, being 0.17 cfs for irrigation and 0.005 cfs for stock water, that the PRIORITY OF THE RIGHT dates from August 5, 1981, and is limited to the amount of water which can be applied to beneficial use and shall not exceed 0.175 cfs measured at the point of diversion from the stream, or its equivalent in case of rotation with other water users.

The POINTS OF DIVERSION are to be LOCATED: Diversion I(Unnamed Stream I) - 340 feet South and 1,100 feet West from the Northeast Corner of Section 6, being within the NE 1/4 NE 1/4 of Section 6; Diversion 2(South Umpqua River) - 1,960 feet South and 925 feet West from the Northeast Corner of Section 6, being within the SE 1/4 NE 1/4 of Section 6; and Diversion 3(Unnamed Stream 2) - 80 feet South and 600 feet West from the Northeast Corner of Section 6, being within the NE 1/4 NE 1/4 of Section 6, all being within Township 30 South, Range 5 West, WM, in the County of Douglas.

A description of the PLACE OF USE under the permit, and to which such right is appurtenant, is as follows:

Township 30 South Range 5 West, WM Section 6 NE 1/4 NE 1/4 13.3 acres irrigetion and stock use

The AMOUNT OF WATER used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to 1/80 of one cubic foot per second per acre, from direct flow and shall be further limited to a diversion of not to exceed 2.5 acre-feet per acre for each acre irrigated during the irrigation season of each year from direct flow and storage from reservoir to be constructed under Permit R-8401, and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

Actual construction work shall begin on or before June 28, 1983 and shall thereafter be prosecuted with reasonable diligence and be completed on or before October 1, 1984.

Complete application of the water to the proposed use shall be made on or before October 1, 1985.
