## PERMIT TO APPROPRIATE THE PUBLIC WATERS

This is to certify that I have examined APPLICATION 63198 and do hereby grant the same SUBJECT TO EXISTING RIGHTS INCLUDING THE APPROPRIATE MINIMUM FLOW POLICIES ESTABLISHED BY THE WATER POLICY REVIEW BOARD and the following limitations and conditions:

This permit is issued to Jerry C. Bruton of Route 1, Box 30, North Powder, Oregon 97867, phone 898-2835, for the use of the waters of two spring fed streams, being 1.36 cubic feet of water per second from Unnamed Stream 1 and 0.34 cfs from Unnamed Stream 2, tributaries of North Powder River, for the PURPOSE of supplemental irrigation; that the PRIORITY OF THE RIGHT dates from January 5, 1982, and is limited to the amount of water which can be applied to beneficial use and shall not exceed 1.7 cfs measured at the point of diversion from the stream, or its equivalent in case of rotation with other water users.

The POINTS OF DIVERSION are to be LOCATED: Diversion I(Unnamed Stream 1) - 378 feet South and 388 feet West from the N 1/4 Corner of Section 24, being within the NE 1/4 NW 1/4 of Section 24 and Diversion 2(Unnamed Stream 2) - 1,510 feet South and 1,300 feet West from the N 1/4 Corner of Section 24, being within the SE 1/4 NW 1/4 of Section 24, both being within Township 6 South, Range 38 East, WM, in the County of Union.

A description of the PLACE OF USE under the permit, and to which such right is appurtenant, is as follows:

The AMOUNT OF WATER used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to 1/40 of one cubic foot per second per acre, from direct flow and shall be further limited to a diversion of not to exceed 4.0 acre-feet per acre for each acre irrigated during the irrigation season of each year, and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

Actual construction work shall begin on or before June 28, 1983 and shall thereafter be prosecuted with reasonable diligence and be completed on or before October 1, 1984.

Complete application of the water to the proposed use shall be made on or before October 1, 1985.
