PERMIT TO APPROPRIATE THE PUBLIC WATERS

This is to certify that I have examined APPLICATION 63248 and do hereby grant the same SUBJECT TO EXISTING RIGHTS INCLUDING THE APPROPRIATE MINIMUM FLOW POLICIES ESTABLISHED BY THE WATER POLICY REVIEW BOARD and the following limitations and conditions:

This permit is issued to David Allen of 18150 Bridgeport Road, Dallas, Oregon 97338, phone 623-3001, for the use of the waters of an unnamed stream and Allen Reservoir to be constructed under Application R-63247, Permit R-8410, for the PURPOSE of supplemental irrigation and stock water, being 0.385 cubic foot of water per second for supplemental irrigation and 0.005 cfs for stock water; that the PRIORITY OF THE RIGHT dates from February 8, 1982, and is limited to the amount of water which can be applied to beneficial use and shall not exceed 0.39 cfs measured at the point of diversion from the stream, or its equivalent in case of rotation with other water users.

The POINTS OF DIVERSION are to be LOCATED: <u>Diversion 2</u> - 90 feet North and 680 feet West from the Southeast Corner of Section 27 and <u>Diversion 3</u> - 270 feet North and 750 feet West from the Southeast Corner of Section 27, both being within the SE 1/4 SE 1/4 of Section 27, Township 8 South, Range 6 West, WM, in the County of Polk.

A description of the PLACE OF USE under the permit, and to which such right is appurtenant, is as follows:

Township 8 South Range 6 West, WM Section 27 SE 1/4 NE 1/4 1.3 acres NE 1/4 SE 1/4 SE 1/4 14.6 acres SE 1/4 SE 1/4 SE 1/4 15.2 acres and stock water

The AMOUNT OF WATER used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to 1/80 of one cubic foot per second per acre, from direct flow and shall be further limited to a diversion of not to exceed 2.5 acre-feet per acre for each acre irrigated during the irrigation season of each year from direct flow and storage from reservoir to be constructed under Permit R-8410, provided further that the right allowed herein shall be limited to any deficiency in the available supply of any prior right existing for the same land and shall not exceed the limitation allowed herein, and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

Actual construction work shall begin on or before June 30, 1983 and shall thereafter be prosecuted with reasonable diligence and be completed on or before October 1, 1984.

Complete application of the water to the proposed use shall be made on or before October 1, 1985.
