PERMIT TO APPROPRIATE THE PUBLIC WATERS

This is to certify that I have examined APPLICATION 62323 and do hereby grant the same SUBJECT TO EXISTING RIGHTS INCLUDING THE APPROPRIATE MINIMUM FLOW POLICIES ESTABLISHED BY THE WATER POLICY REVIEW BOARD and the following limitations and conditions:

This permit is issued to John T. Ostler of 13005 SW Morgan Road, Sherwood, Oregon 97140, phone 625-7613, for the use of the waters of Rock Creek, a spring and a reservoir to be constructed under Application R-62322, Permit R-8436, being 0.065 cubic font of water per second from Rock Creek and 0.005 cfs from the spring for the PURPOSE of irrigation and stock water, being 0.06 cfs from Rock Creek for irrigation; 0.005 cfs from Rock Creek and 0.005 cfs from the spring and 0.3 acre-feet stored water only from the reservoir for stock water; that the PRIORITY OF THE RIGHT dates from June 18, 1982, and is limited to the amount of water which can be applied to beneficial use and shall not exceed 0.07 cfs measured at the point of diversion from the stream, or its equivalent in case of rotation with other water users.

The POINTS OF DIVERSION are to be LOCATED: <u>Diversion 1(Rock Creek) - 1,370</u> feet South and 1,110 feet West from the Northeast Corner of Section 4; <u>Diversion 2(Rock Creek) - 2,000</u> feet South and 1,110 feet West from the Northeast Corner of Section 4; <u>Diversion 3(Rock Creek) - 1,720</u> feet South and 1,110 feet West from the Northeast Corner of Section 4; and <u>Diversion 4(Spring and Reservoir) - 1,700</u> feet South and 1,220 feet West from the Northeast Corner of Section 4, all being within the SE 1/4 NE 1/4 of Section 4, Township 3 South, Range 1 West, WM, in the County of Clackames.

A description of the PLACE OF USE under the permit, and to which such right is appurtenant, is as follows:

Township 3 South Range I West, WM Section 4 SW 1/4 NE 1/4 1.7 acres SE 1/4 NE 1/4 3.3 acres SE 1/4 NE 1/4 Stock water

The AMOUNT OF WATER used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to 1/80 of one cubic foot per second per acre, from direct flow and shall be further limited to a diversion of not to exceed 2.5 acre-feet per acre for each acre irrigated during the irrigation season of each year, provided further that water shall not be appropriated from direct flow during the period from July I through September 15 of each year except for livestock consumption, and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

Actual construction work shall begin on or before July 13, 1983 and shall thereafter be prosecuted with reasonable diligence and be completed on or before October 1, 1984.

Complete application of the water to the proposed use shall be made on or before October 1, 1985.
