PERMIT TO APPROPRIATE THE PUBLIC WATERS

This is to certify that I have examined APPLICATION 63268 and do hereby grant the same SUBJECT TO EXISTING RIGHTS INCLUDING THE APPROPRIATE MINIMUM FLOW POLICIES ESTABLISHED BY THE WATER POLICY REVIEW BOARD and the following limitations and conditions:

This permit is issued to Crystal Springs Packing Company, Inc., by Duane Culbertson, of 327 South Fir Street, Medford, Oregon 97501, phone 772-4298, for the use of the waters of Black Oak North Reservoir and Black Oak South Reservoir to be constructed under Application R-63267, Permit R-8437, being 9.1 acre-feet in Black Oak North Reservoir and 5.9 acre-feet in Black Oak South Reservoir, for the PURPOSE of frost protection; that the PRIORITY OF THE RIGHT dates from February 17, 1982, and is limited to the amount of water which can be applied to beneficial use and shall not exceed 15.0 acre-feet stored water only.

The POINTS OF DIVERSION are to be LOCATED: Diversion I(Black Oak North Reservoir) - 2,150 feet North and 1,450 feet West from the Southeast Corner of Section 8; Diversion 2(Black Oak South Reservoir) - 1,900 feet North and 1,430 feet West from the Southeast Corner of Section 8, both being within the NW 1/4 SE 1/4 of Section 8; and Diversion 3(Telent Irrigation Canel) - 3,840 feet South and 1,700 feet West from the Southeast Corner of Section 8, being within the NW 1/4 SW 1/4 of Section 17, all within Township 38 South, Range I West, WM, in the County of Jackson.

A description of the PLACE OF USE under the permit, and to which such right is appurtenant, is as follows:

The permittee shall record and submit annually to the Water Resources Department all pertinent data pertaining to use of water for temperature control (frost protection) on forms furnished.

Actual construction work shall begin on or before July 13, 1983 and shall thereafter be prosecuted with reasonable diligence and be completed on or before October 1, 1984.

Complete application of the water to the proposed use shall be made on or before October 1, 1985.
