PERMIT TO APPROPRIATE THE PUBLIC WATERS

This is to certify that I have examined APPLICATION 63384 and do hereby grant the same SUBJECT TO EXISTING RIGHTS INCLUDING THE APPROPRIATE MINIMUM FLOW POLICIES ESTABLISHED BY THE WATER POLICY REVIEW BOARD and the following limitations and conditions:

This permit is issued to William F. Bonebrake of 2221 Metrose Road, Roseburg, Oregon 97470, phone 673-4728, for the use of the waters of South Umpqua River, a tributary of Umpqua River, for the PURPOSE of Irrigation; that the priority of the right dates from March 8, 1982, and is limited to the amount of water which can be applied to beneficial use and shall not exceed 0.23 cubic foot per second measured at the point of diversion from the stream, or its equivalent in case of rotation with other water users.

The POINTS OF DIVERSION are to be LOCATED: Diversion 1 - 3,350 feet North and 2,650 feet East from the Corner common to Sections 5,6,7 and 8, being within the SE 1/4 NW 1/4 of Section 5 and Diversion 2 - 4,390 feet North and 3,590 feet East from the Corner common to Sections 5,6,7 and 8, being within the NW 1/4 NE 1/4 of Section 5, both within Township 27 South, Range 6 West, WM, in the County of Douglas.

A description of the PLACE OF USE under the permit, and to which such right is appurtenant, is as follows:

The AMOUNT OF WATER used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to 1/80 of one cubic foot per second per acre, from direct flow and shall be further limited to a diversion of not to exceed 2.5 acre-feet per acre for each acre irrigated during the irrigation season of each year, and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

Actual construction work shall begin on or before July 13, 1983 and shall thereafter be prosecuted with reasonable diligence and be completed on or before October 1, 1984.

Complete application of the water to the proposed use shall be made on or before October 1, 1985.
