## PERMIT TO APPROPRIATE THE PUBLIC WATERS

This is to certify that I have examined APPLICATION 63386 and do hereby grant the same TO EXISTING RIGHTS INCLUDING THE APPROPRIATE MINIMUM FLOW POLICIES ESTABLISHED BY THE WATER POLICY REVIEW BOARD and the following limitations and conditions:

This permit is issued to Allen R. and Stephanie L. Gillmore of 1295 Larson Way, North Bend, Oregon 97459, phone 756-7952, for the use of the waters of a spring, an unnamed stream and Larson Creek, being 0.015 cubic foot of water per second from the spring, 0.03 cfs from the unnamed stream and 0.03 cfs from Larson Creek, for the PURPOSE of irrigation and domestic use for one family, being 0.005 cfs from the spring for domestic use for one family and 0.01 cfs from the spring, 0.03 cfs from the unnamed stream and 0.03 cfs from Larson Creek for irrigation; that the PRIORITIES OF THE RIGHT date from March 8, 1982 for 0.07 cfs and April 19, 1982 for 0.005 cfs, and is limited to the amount of water which can be applied to beneficial use and shall not exceed 0.075 cfs measured at the point of diversion from the stream, or its equivalent in case of rotation with other water users.

The POINTS OF DIVERSION are to be LOCATED: Diversion I(Spring) - 190 feet North and 330 feet West from the E1/4 Corner of Section 16, being within the SE1/4 NE1/4 of Section 16; Diversion 2(Unnamed Stream) - 145 feet South and 255 feet West from the E1/4 Corner of Section 16, being within the NE 1/4 SE 1/4 of Section 16; and Diversion 3(Larson Creek) - 265 feet South and 170 feet East from the E1/4 Corner of Section 16, being within the NW 1/4 SW 1/4 of Section 15, all within Township 24 South, Range 12 West, WM, in the County of Coos.

A description of the PLACE OF USE under the permit, and to which such right is appurtenant, is as follows:

Township 24 South Range 12 West, WM Section 15

NW 1/4 SW 1/4 SE 1/4 Section 16 NE 1/4

2.5 acres irrigation Domestic use for one family including irrigation of onehalf acre lawn and noncommercial garden

NE 1/4 SE 1/4

2.5 acres irrigation

The AMOUNT OF WATER used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to 1/80 of one cubic foot per second per acre, from direct flow and shall be further limited to a diversion of not to exceed 2.5 acre-feet per acre for each acre irrigated during the irrigation season of each year, and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

Actual construction work shall begin on or before July 13, 1983 and shall thereafter be prosecuted with reasonable diligence and be completed on or before October 1, 1984.

Complete application of the water to the proposed use shall be made on or before October 1, 1985.
