PERMIT TO APPROPRIATE THE PUBLIC WATERS

This is to certify that I have examined APPLICATION 62958 and do hereby grant the same SUBJECT TO EXISTING RIGHTS INCLUDING THE APPROPRIATE MINIMUM FLOW POLICIES ESTABLISHED BY THE WATER POLICY REVIEW BOARD and the following limitations and conditions:

This permit is issued to Monroe Acres by Helen Brandes of Kernville Route 537, Lincoln City, Oregon 97367, phone 996-2060, for the use of the waters of an unnamed stream (sometimes called Echo Falls), a tributary of Siletz River, for the PURPOSE of commercial use at a trailer park and public restrooms and for domestic supplies for 19 families including irrigation of not to exceed one-half acre in area for each family, being 0.02 cubic foot per second of water for commercial use, and 0.06 cfs for domestic use; that the PRIORITY OF THE RIGHT dates from October 9, 1981, and is limited to the amount of water which can be applied to beneficial use and shall not exceed 0.08 cfs measured at the point of diversion from the stream, or its equivalent in case of rotation with other water users.

The POINT OF DIVERSION is to be LOCATED: 1,278 feet North 50 degrees 10 feet West from the Northeast Corner of Section 17, being within the SW 1/4 SE 1/4 of Section 8, Township 8 South, Range 10 West, WM, in the County of Lincoln.

A description of the PLACE OF USE under the permit, and to which such right is appurtenant, is as follows:

Actual construction work shall begin on or before July 30, 1983 and shall thereafter be prosecuted with reasonable diligence and be completed on or before October 1, 1984.

Complete application of the water to the proposed use shall be made on or before October 1, 1985.
