PERMIT TO APPROPRIATE THE PUBLIC WATERS

This is to certify that I have examined APPLICATION 63556 and do hereby grant the same SUBJECT TO EXISTING RIGHTS INCLUDING THE APPROPRIATE MINIMUM FLOW POLICIES ESTABLISHED BY THE WATER POLICY REVIEW BOARD and the following limitations and conditions:

This permit is issued to Eagle Point Irrigation District by Hazel Brown, Manager, of PO Box 157, 225 West Main, Eagle Point, Oregon 97524, phone 826-3411, for the use of the waters of Hog Creek, a tributary of Rogue River, for the PURPOSE of irrigation; that the PRIORITIES OF THE RIGHT date from May 21, 1982 for 0.43 cubic foot of water per second and July 14, 1982 for 0.02 cfs, and is limited to the amount of water which can be applied to beneficial use and shall not exceed 0.45 cfs measured at the point of diversion from the stream, or its equivalent in case of rotation with other water users.

The POINTS OF DIVERSION are to be LOCATED: Diversion 1 - 300 feet South and 1,500 feet West from the Northeast Corner of Section 21, being within the NW 1/4 NE 1/4 of Section 21; Diversion 2 - 1,100 feet South and 70 feet West from the N 1/4 Corner of Section 21, being within the NE 1/4 NW 1/4 of Section 21; Diversion 3 - 1,290 feet South and 400 feet West from the N 1/4 Corner of Section 21, being within the NE 1/4 NW 1/4 of Section 21; and Diversion 4 - 90 feet North and 1,160 feet East from the W 1/4 Corner of Section 21, being within the SW 1/4 NW 1/4 of Section 21, all within Township 35 South, Range 1 West, WM, in the County of Jackson.

A description of the PLACE OF USE under the permit, and to which such right is appurtenant, is as follows:

The AMOUNT OF WATER used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to 1/80 of one cubic foot per second per acre, from direct flow and shall be further limited to a diversion of not to exceed 4.5 acre-feet per acre for each acre irrigated during the irrigation season of each year, and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

Actual construction work shall begin on or before August 16, 1983 and shall thereafter be prosecuted with reasonable diligence and be completed on or before October 1, 1984.

Complete application of the water to the proposed use shall be made on or before October 1, 1985.
