PERMIT TO APPROPRIATE THE PUBLIC WATERS

This is to certify that I have examined APPLICATION 63608 and do hereby grant the same SUBJECT TO EXISTING RIGHTS INCLUDING THE APPROPRIATE MINIMUM FLOW POLICIES ESTABLISHED BY THE WATER POLICY REVIEW BOARD and the following limitations and conditions:

This permit is issued to City of Lincoln City of City Hall, PO Box 50, Lincoln City, Oregon 97367, phone 996-2151, for the use of the waters of Schooner Creek, provided that the amount of water allowed herein together with the amount of water allowed under Permit G-9827, shall not exceed a total of 6.0 cubic feet per second, a tributary of Pacific Ocean, for the PURPOSE of municipal use; that the PRIORITY OF THE RIGHT dates from June 8, 1982, and is limited to the amount of water which can be applied to beneficial use and shall not exceed 6.0 cfs measured at the point of diversion from the stream, or its equivalent in case of rotation with other water users.

The POINT OF DIVERSION is to be LOCATED: 200 feet North and 820 feet West from the E 1/4 Corner of Section 25, being within the SE 1/4 NE 1/4 of Section 25, Township 7 South, Range 11 West, WM, in the County of Lincoln.
