PERMIT TO APPROPRIATE THE PUBLIC WATERS

This is to certify that I have examined APPLICATION 62375 and do hereby grant the same SUBJECT TO EXISTING RIGHTS INCLUDING THE APPROPRIATE MINIMUM FLOW POLICIES ESTABLISHED BY THE WATER POLICY REVIEW BOARD and the following limitations and conditions:

This permit is issued to Dayton Hyde of PO Box 371, Chiloquin, Oregon 97624, phone 783-2403, for the use of the waters of John Day River, a tributary of Columbia River, for the PURPOSE of irridation and supplemental irrigation; that the PRIORITY OF THE RIGHT dates from July 14, 1982, and is limited to the amount of water which can be applied to beneficial use and shall not exceed 0.81 cubic foot per second measured at the point of diversion from the stream, or its equivalent in case of rotation with other water users.

The POINT OF DIVERSION is to be LOCATED: 400 feet South and 1,550 feet East from the Northwest Corner of Section 35, being within the NE 1/4 NW 1/4 of Section 35, Township 12 South, Range 26 East, WM, in the County of Grant.

A description of the PLACE OF USE under the permit, and to which such right is appurtenant, is as follows:

Township 12 South Range 26 East, WM Section 35

Primary irrigation
NW 1/4 NE 1/4 11.1 acres
NE 1/4 NW 1/4 3.8 acres

NW 1/4 NE 1/4 9.0 acres NE 1/4 NW 1/4 26.0 acres

The AMOUNT OF WATER used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to 1/40 of one cubic foot per second per acre irrigated, and shall be further limited, together with the amount secured under any existing right for the same lands, to 5.0 acre-feet per acre for each acre irrigated during the irrigation season of each year, and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

Actual construction work shall begin on or before August 31, 1983 and shall thereafter be prosecuted with reasonable diligence and be completed on or before October 1, 1984.

Complete application of the water to the proposed use shall be made on or before October 1, 1985.
