PERMIT TO APPROPRIATE THE PUBLIC WATERS

This is to certify that I have examined APPLICATION 62409 and do hereby grant the same SUBJECT TO EXISTING RIGHTS INCLUDING THE APPROPRIATE MINIMUM FLOW POLICIES ESTABLISHED BY THE WATER POLICY REVIEW BOARD and the following limitations and conditions:

This permit is issued to Alan Arthur Haga of Route 1, Box 1553, Bandon, Oregon 97411, phone 347-3811, for the use of the waters of an unnamed stream, Willow Creek, and Floras Creek, for the PURPOSE of irrigation, supplemental irrigation, temperature control, and flood harvesting of cranberries, being 12.15 cubic feet per second from the unnamed stream when available with any deficiency in the available supply from the unnamed stream to be made up by appropriation from Willow Creek and Floras Creek, being 2.03 cfs for cranberry irrigation, 12.15 cfs for temperature control, and 4.05 cfs for flood harvesting on 81.0 acres, 0.85 cfs from the unnamed stream for supplemental irrigation of 69.7 acres, and 0.25 cfs from Willow Creek for irrigation of 20.0 acres; that the PRIORITY OF THE RIGHT dates from August 25, 1981, and is limited to the amount of water which can be applied to beneficial use and shall not exceed 13.25 cfs measured at the points of diversion from the stream, or their equivalent in case of rotation with other water users.

The POINTS OF DIVERSION are to be LOCATED: Diversion 1 (Unnamed Stream) - ~~1,236~~ feet South and 1,795 feet East from the Northwest Corner of Section 9, being within the NE 1/4 SW 1/4 of Section 9; Diversion 2 (Willow Creek) - 3,564 feet South and 4,092 feet East from the Northwest Corner of Section 9, being within the NE 1/4 SE 1/4 of Section 9; Diversion 3 (Floras Creek) - 660 feet North and 762 feet West from the Northwest Corner of Section 9, being within the SE 1/4 SE 1/4 of Section 5, all being within Township 31 South, Range 15 West, WM, in the County of Curry.

A description of the PLACE OF USE under the permit, and to which such right is appurtenant, is as follows:

If for irrigation, this appropriation shall be limited to 1/40 of one cubic foot per second of its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 3.0 acre-feet per acre for each acre irrigated during the irrigation season of each year, for cranberries. If for the irrigation of any other crop, this appropriation shall be limited to 1/80 of one cubic foot per second or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2.5 acre-feet per acre for each acre irrigated during the irrigation season of each year, provided further that the right allowed herein shall be limited to any deficiency in the available supply of any prior right existing for the same land and shall not exceed the limitation allowed herein, and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

The permittee shall record and submit annually to the Water Resources Department all pertinent data pertaining to use of water for temperature control (frost protection) on forms furnished.

Actual construction work shall begin on or before August 31, 1983 and shall thereafter be prosecuted with reasonable diligence and be completed on or before October 1, 1984.

Complete application of the water to the proposed use shall be made on or before October 1, 1985.
