PERMIT TO APPROPRIATE THE PUBLIC WATERS

This is to certify that I have examined APPLICATION 63503 and do hereby grant the same SUBJECT TO EXISTING RIGHTS INCLUDING THE APPROPRIATE MINIMUM FLOW POLICIES ESTABLISHED BY THE WATER POLICY REVIEW BOARD and the following limitations and conditions:

This permit is issued to Frank and Manuel Silva of Kimberly, Oregon 97848, for the use of the waters of North Fork John Day River, a tributary of John Day River, for the PURPOSE of irrigation; that the PRIORITIES OF THE RIGHT date from June 28, 1982 for 0.82 cubic foot of water per second and August 4, 1982 for 0.18 cfs, and is limited to the amount of water which can be applied to beneficial use and shall not exceed 1.0 cfs measured at the point of diversion from the stream, or its equivalent in case of rotation with other water users.

The POINTS OF DIVERSION are to be LOCATED: Diversion 1 - 2,300 feet South and 3,820 feet West from the Northeast Corner of the SW 1/4 SW 1/4 of Section 4, being within the NW 1/4 NE 1/4 of Section 8, and Diversion 2 - 1,650 feet South and 2,450 feet West from the Northeast Corner of the SW 1/4 SW 1/4 of Section 4, being within the NE 1/4 NE 1/4 of Section 8, Township 9 South, Range 27 East, WM, in the County of Grant.

A description of the PLACE OF USE under the permit, and to which such right is appurtenant, is as follows:

The AMOUNT OF WATER used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to 1/40 of one cubic foot per second per acre, from direct flow and shall be further limited to a diversion of not to exceed 5.0 acre-feet per acre for each acre irrigated during the irrigation season of each year, and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

Actual construction work shall begin on or before September 9, 1983 and shall thereafter be prosecuted with reasonable diligence and be completed on or before October 1, 1984.

Complete application of the water to the proposed use shall be made on or before October 1, 1985.
