PERMIT TO APPROPRIATE THE PUBLIC WATERS

This is to certify that I have examined APPLICATION 63000 and do hereby grant the same SUBJECT TO EXISTING RIGHTS INCLUDING THE APPROPRIATE MINIMUM FLOW POLICIES ESTABLISHED BY THE WATER POLICY REVIEW BOARD and the following limitations and conditions:

This permit is issued to Michael N. Watson of 222 Watson Lane, Idleyld, Oregon 97447, phone 496-3649, for the use of the waters of three springs, being 0.01 cubic foot of water per second from each spring with any deficiency in the available supply from the springs to be made up by diversion of water from North Umpqua River, for the PURPOSE of domestic supplies for five families including irrigation of lawns and noncommercial gardens not exceeding one-half acre in area for each family; that the PRIORITY OF THE RIGHT dates from October 27, 1981, and is limited to the amount of water which can be applied to beneficial use and shall not exceed 0.03 cfs measured at the point of diversion from the springs, or its equivalent in case of rotation with other water users.

The POINTS OF DIVERSION are to be LOCATED: Diversion I(Spring I) - 350 feet North and 70 feet West from the Corner common to Sections 2,3,10 and 11, being within the SE 1/4 SE 1/4 of Section 3; Diversion 2(Spring 2) - 300 feet North and 70 feet West from the Corner common to Sections 2,3,10 and 11, being within the SE 1/4 SE 1/4 of Section 3; Diversion 3(Spring 3) - 120 feet South and 300 feet East from the Corner common to Sections 2,3,10 and 11, being within the NW I/4 NW I/4 of Section II; Diversion 4(North Umpqua River) - 2,640 feet South and 400 feet East from the Corner common to Sections 2,3,10 and 11, being within the SW 1/4 NW 1/4 of Section 11, all within Township 26 South, Range 3 West, WM, in the County of Douglas.

A description of the PLACE OF USE under the permit, and to which such right is appurtenant, is as follows:

Township 26 South Range 3 West, WM Section 11 NW 1/4 NW 1/4 Domestic use for two

families including irrigation of lawns and noncommercial gardens not exceeding one-half acre in area

for each SW 1/4 NW 1/4 Domestic use for three families including irrigation of lawns and noncommercial gardens not exceeding one-half acre in area for each

Actual construction work shall begin on or before September 29, 1983 and shall thereafter be prosecuted with reasonable diligence and be completed on or before October 1, 1984.

Complete application of the water to the proposed use shall be made on or before October 1, 1985.
