PERMIT TO APPROPRIATE THE PUBLIC WATERS

This is to certify that I have examined APPLICATION 63809 and do hereby grant the same SUBJECT TO EXISTING RIGHTS INCLUDING THE APPROPRIATE MINIMUM FLOW POLICIES ESTABLISHED BY THE WATER POLICY REVIEW BOARD and the following limitations and conditions:

This permit is issued to Marvin John and Patricia Ann DeRaeve of Route 1, Box 303, Amity, Oregon 97101, phone 835-6723, for the use of the waters of Ash Swale and DeRaeve Reservoir constructed under Permit R-6487, tributaries of Salt Creek, for the PURPOSE of irrigation; that the PRIORITY OF THE RIGHT dates from July 30, 1982, and is limited to the amount of water which can be applied to beneficial use and shall not exceed 6.07 cubic feet per second measured at the point of diversion from the stream, or its equivalent in case of rotation with other water users.

The POINT OF DIVERSION is to be LOCATED: 2,600 feet North and 1,020 feet West from the Southeast Corner of Section 7, being within the NE I/4 SE I/4 of Section 7, Township County, Range 4 West, WM, in the County of Polk.

The AMOUNT OF WATER used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to 1/80 of one cubic foot per second per acre, from direct flow and shall be further limited to a diversion of not to exceed 2.5 acre-feet per acre for each acre irrigated during the irrigation season of each year from direct flow and storage from reservoir to be constructed under Permit R-6487, and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

Actual construction work shall begin on or before September 29, 1983 and shall thereafter be prosecuted with reasonable diligence and be completed on or before October 1, 1984.

Complete application of the water to the proposed use shall be made on or before October 1, 1985. Extended to October 1, 1988
