## PERMIT TO APPROPRIATE THE PUBLIC WATERS

This is to certify that I have examined APPLICATION 63269 and do hereby grant the same SUBJECT TO EXISTING RIGHTS INCLUDING THE APPROPRIATE MINIMUM FLOW POLICIES ESTABLISHED BY THE WATER POLICY REVIEW BOARD and the following limitations and conditions:

This permit is issued to Hammond Ranches of General Delivery, Diamond, Oregon 97722, phone 493-2324, for the use of the waters of Kern Brothers Reservoir to be enlarged under Application R-60079, Permit R-8487, for the PURPOSE of irrigation; that the PRIORITY OF THE RIGHT dates from February 17, 1982, and is limited to the amount of water which can be applied to beneficial use and shall not exceed 1,028.0 acre-feet stored water only.

The POINT OF DIVERSION is to be LOCATED: 1,400 feet South and 450 feet East from the Northwest Corner of the NE 1/4 SE 1/4 of Section 32, being within the SE 1/4 SE 1/4 of Section 32, Township 30 South, Range 32 East, WM, in the County of Harney.
