PERMIT TO APPROPRIATE THE PUBLIC WATERS

This is to certify that I have examined APPLICATION 63495 and do hereby grant the same SUBJECT TO EXISTING RIGHTS INCLUDING THE APPROPRIATE MINIMUM FLOW POLICIES ESTABLISHED BY THE WATER POLICY REVIEW BOARD and the following limitations and conditions:

This permit is issued to Lila Mae Clarno of 13050 Magnolia Boulevard, Sherman Oaks, California 91423, phone (213)995-4287, for the use of the waters of a spring and Steel Creek, tributaries of East Fork Coquille River, for the PURPOSE of domestic use for four families and irrigation, being 0.01 cubic foot per second of water from the spring with any deficiency in the available supply from the spring to be made up by diversion from Steel Creek for domestic supplies for three families, 0.01 cfs from Steel Creek for domestic supplies for one family including irrigation of not to exceed one-half acre lawn and noncommercial garden, and 0.25 cfs from Steel Creek for irrigation; that the PRIORITY OF THE RIGHT dates from April 28, 1982, and is limited to the amount of water which can be applied to beneficial use and shall not exceed 0.27 cubic foot per second measured at the points of diversion from the stream, or their equivalent in case of rotation with other water users.

The POINTS OF DIVERSION are to be LOCATED: Diversion 1 (Steel Creek) - 580 feet North and 970 feet East from the W 1/4 Corner of Section 12, being within the SW 1/4 NW 1/4 of Section 12; Diversion 2 (Spring) - 420 feet North and 510 feet East from the W 1/4 Corner of Section 12, being within the SW 1/4 NW 1/4 of Section 12; Diversion 3 (Steel Creek) - 150 feet North and 1,020 feet East from the W 1/4 Corner of Section 12, being within the SW 1/4 NW 1/4 of Section 12; Diversion 4 (Steel Creek) - 270 feet South and 710 feet East from the W 1/4 Corner of Section 12, being within the NW 1/4 SW 1/4 of Section 12, all being within Township 28 South, Range 11 West, WM, in the County of Coos.

A description of the PLACE OF USE under the permit, and to which such right is appurtenant, is as follows:

Township 28 South Range 11 West, WM Section 12 SW 1/4 NW 1/4 Domestic use for House 1 to include up to 0.5 acre irrigation of lawn and noncommercial garden from Diversion 1 and domestic use for House 2 from Divisions 2 and 3
NW 1/4 SW 1/4 Domestic use for Houses 3 and 4 from Divisions 2 and 3, and 20.0 acres irrigation from Diversion 4

The AMOUNT OF WATER used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to 1/80 of one cubic foot per second per acre, from direct flow and shall be further limited to a diversion of not to exceed 2.5 acre-feet per acre for each acre irrigated during the irrigation season of each year, and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

Actual construction work shall begin on or before October 20, 1983 and shall thereafter be prosecuted with reasonable diligence and be completed on or before October 1, 1984.

Complete application of the water to the proposed use shall be made on or before October 1, 1985.
