## PERMIT TO APPROPRIATE THE PUBLIC WATERS

This is to certify that I have examined APPLICATION 63228 and do hereby grant the same SUBJECT TO EXISTING RIGHTS INCLUDING THE APPROPRIATE MINIMUM FLOW POLICIES ESTABLISHED BY THE WATER POLICY REVIEW BOARD and the following limitations and conditions:

This permit is issued to Craig A. Snyder of PO Box 654, Wamic, Oregon 97063, phone 544-3561, for the use of the waters of an unnamed draw and reservoirs constructed under Permit R-8139 and Application R-64058, Permit R-8502, tributaries of White River, for the PURPOSE of supplemental irrigation; that the PRIORITY OF THE RIGHT dates from January 26, 1982, and is limited to the amount of water which can be applied to beneficial use and shall not exceed 2.0 cubic feet per second measured at the points of diversion from the stream, or their equivalent in case of rotation with other water users.

The POINTS OF DIVERSION are to be LOCATED: Diversion 1 - 3,160 feet South and 650 feet East from the Northwest Corner of Section 24, being within the NW 1/4 SW 1/4 of Section 24, Township 4 South, Range 12 East, WM; Diversion 2 - 1,300 feet South and 2,550 feet East from the Northwest Corner of Section 19, being within the NE 1/4 NW 1/4 of Section 19, Township 4 South, Range 13 East, WM, both in the County of Wasco.

A description of the PLACE OF USE under the permit, and to which such right is appurtenant, is as follows:

The AMOUNT OF WATER used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to 1/40 of one cubic foot per second per acre, from direct flow and shall be further limited to a diversion of not to exceed 3.0 acre-feet per acre for each acre irrigated during the irrigation season of each year from direct flow and storage from reservoir constructed under Permits R-8139 and R-8502, provided further that the right allowed herein shall be limited to any deficiency in the available supply of any prior right existing for the same land and shall not exceed the limitation allowed herein, and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

Actual construction work shall begin on or before October 28, 1983 and shall thereafter be prosecuted with reasonable diligence and be completed on or before October 1, 1984.

Complete application of the water to the proposed use shall be made on or before October 1, 1985.
