## PERMIT TO APPROPRIATE THE PUBLIC WATERS

This is to certify that I have examined APPLICATION 63967 and do hereby grant the same SUBJECT TO EXISTING RIGHTS INCLUDING THE APPROPRIATE MINIMUM FLOW POLICIES ESTABLISHED BY THE WATER POLICY REVIEW BOARD and the following limitations and conditions:

This permit is issued to Gary O. Davis of Star Route, Box 780, Forest Grove, Oregon 97116, phone 357-8710, for the use of the waters of an unnamed stream, a tributary of Gales Creek, for the PURPOSE of domestic use for one family and irrigation; being 0.005 cubic foot per second of water for domestic use and 0.01 cfs for irrigation; that the PRIORITY OF THE RIGHT dates from August 30, 1982, and is limited to the amount of water which can be applied to beneficial use and shall not exceed 0.015 cfs measured at the points of diversion from the stream, or their equivalent in case of rotation with other water users.

The POINTS OF DIVERSION are to be LOCATED: <u>Diversion 1</u> - 492 feet South and 640 feet West; <u>Diversion 2</u> - 475 feet South and 720 feet West, both from the Northeast Corner of SW 1/4 NE 1/4 of Section 26, being within the SW 1/4 NE 1/4 of Section 26, Township 2 North, Range 5 West, WM, in the County of Washington.

A description of the PLACE OF USE under the permit, and to which such right is appurtenant, is as follows:

Township 2 North Range 5 West, WM Section 26 SW 1/4 NE 1/4 Domestic use for one family and 0.5 acre

The AMOUNT OF WATER used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to 1/80 of one cubic foot per second per acre, from direct flow and shall be further limited to a diversion of not to exceed 2.5 acre-feet per acre for each acre irrigated during the irrigation season of each year, provided further water shall not be appropriated from direct flow during the period from July 31 through September 15 of each year except for human consumption, and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

Actual construction work shall begin on or before November 3, 1983 and shall thereafter be prosecuted with reasonable diligence and be completed on or before October 1, 1984.

Complete application of the water to the proposed use shall be made on or before October 1, 1985.
