PERMIT TO APPROPRIATE THE PUBLIC WATERS

This is to certify that I have examined APPLICATION 63766 and do hereby grant the same SUBJECT TO EXISTING RIGHTS INCLUDING THE APPROPRIATE MINIMUM FLOW POLICIES ESTABLISHED BY THE WATER POLICY REVIEW BOARD and the following limitations and conditions:

This permit is issued to Glenn A. Walters of Route 4, Box 135-J, Cornelius, Oregon 97113, phone 640-4633, for the use of the waters of a reservoir to be constructed under Application R-63765, Permit R-8515, a tributary of Tualatin River, for the PURPOSE of irrigation and supplemental irrigation; that the PRIORITY OF THE RIGHT dates from July 15, 1982, and is limited to the amount of water which can be applied to beneficial use and shall not exceed 102.0 acre-feet stored water only.

The POINT OF DIVERSION is to be LOCATED: 1,200 feet South and 2,000 feet East from the Northwest Corner of Section 22, being within the NE 1/4 NW 1/4 of Section 22, Township 1 South, Range 3 West, WM, in the County of Washington.

A description of the PLACE OF USE under the permit, and to which such right is appurtenant, is as follows:

Township I South Range 3 West, WM Section 22

Primary irrigation
NE 1/4 NW 1/4 15.0 acres
SE 1/4 NW 1/4 25.0 acres

SE 1/4 NW 1/4 5.0 acres SE 1/4 NW 1/4 5.0 acres

The AMOUNT OF WATER used for irrigation, together with the amount secured under any other right existing for the same lands, shall be further limited to a diversion of not to exceed 2.5 acre-feet per acre for each acre irrigated during the irrigation season of each year from storage from reservoir to be constructed under Permit R-8515, provided further that the right allowed herein shall be limited to any deficiency in the available supply of any prior right existing for the same land and shall not exceed the limitation allowed herein, and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

Actual construction work shall begin on or before November 23, 1983 and shall thereafter be prosecuted with reasonable diligence and be completed on or before October 1, 1984.

Complete application of the water to the proposed use shall be made on or before October l, 1985. Extended to Oct. 1, 1986
