PERMIT TO APPROPRIATE THE PUBLIC WATERS

This is to certify that I have examined APPLICATION 64157 and do hereby grant the same SUBJECT TO EXISTING RIGHTS INCLUDING THE APPROPRIATE MINIMUM FLOW POLICIES ESTABLISHED BY THE WATER POLICY REVIEW BOARD and the following limitations and conditions:

This permit is issued to Hong-Shiou Chiou of 1084 Highway 101, PO Box 98, Florence, Oregon 97439, phone 997-3481, for the use of the waters of an unnamed stream, a tributary of Siuslaw River, for the PURPOSE of irrigation and livestock use, being 0.14 cubic foot of water per second for irrigation and 0.01 cfs for livestock use; that the PRIORITY OF THE RIGHT dates from September 14, 1982 for 0.10 cfs and November 10, 1982 for 0.05 cfs, and is limited to the amount of water which can be applied to beneficial use and shall not exceed 0.145 cfs measured at the point of diversion from the stream, or its equivalent in case of rotation with other water users.

The POINT OF DIVERSION is to be LOCATED: 40 feet South and 390 feet East from the Northwest Corner of the SW 1/4 SE 1/4 of Section 16, being within the SW 1/4 SE 1/4 of Section 16, Township 18 South, Range 11 West, WM, in the County of Lane.

A description of the PLACE OF USE under the permit, and to which such right is appurtenant, is as follows:

The AMOUNT OF WATER used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to 1/80 of one cubic foot per second per acre, from direct flow and shall be further limited to a diversion of not to exceed 2.5 acre-feet per acre for each acre irrigated during the irrigation season of each year, and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

Actual construction work shall begin on or before November 30, 1983 and shall thereafter be prosecuted with reasonable diligence and be completed on or before October 1, 1984.

Complete application of the water to the proposed use shall be made on or before October 1, 1985.
