PERMIT TO APPROPRIATE THE PUBLIC WATERS

This is to certify that I have examined APPLICATION 63816 and do hereby grant the same SUBJECT TO EXISTING RIGHTS INCLUDING THE APPROPRIATE MINIMUM FLOW POLICIES ESTABLISHED BY THE WATER POLICY REVIEW BOARD and the following limitations and conditions:

This permit is issued to Major A. Anderson of 3505 Dallas Highway, NW, Salem, Oregon 97304, phone 364-5925, for the use of the waters of an unnamed creek, a tributary of Willamette River, for the PURPOSE of irrigation; that the PRIORITY OF THE RIGHT dates from August 2, 1982 for 0.01 cubic foot per second of water and November 8, 1982 for 0.01 cfs, and is limited to the amount of water which can be applied to beneficial use and shall not exceed 0.02 cfs measured at the point of diversion from the stream, or its equivalent in case of rotation with other water users.

The POINT OF DIVERSION is to be LOCATED: 570 feet North and 2,210 feet West from the Southeast Corner of SW 1/4 NE 1/4 of Section 30, being within the SW 1/4 NE 1/4 of Section 30, Township 7 South, Range 3 West, WM, in the County of Polk.

A description of the PLACE OF USE under the permit, and to which such right is appurtenant, is as follows:

Township 7 South Range 3 West, WM Section 30 SW 1/4 NE 1/4 0.75 acre NW 1/4 SE 1/4 1.0 acre

The AMOUNT OF WATER used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to 1/80 of one cubic foot per second per acre, from direct flow and shall be further limited to a diversion of not to exceed 2.5 acre-feet per acre for each acre irrigated during the irrigation season of each year, and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

Actual construction work shall begin on or before January 7, 1984 and shall thereafter be prosecuted with reasonable diligence and be completed on or before October 1, 1984.

Complete application of the water to the proposed use shall be made on or before October 1, 1985.
