PERMIT TO APPROPRIATE THE PUBLIC WATERS

This is to certify that I have examined APPLICATION 64509 and do hereby grant the same SUBJECT TO EXISTING RIGHTS INCLUDING THE APPROPRIATE MINIMUM FLOW POLICIES ESTABLISHED BY THE WATER POLICY REVIEW BOARD and the following limitations and conditions:

This permit is issued to Don Meacham of Izee Route, Canyon City, Cregon 97820, phone 575-0198, for the use of the waters of East Fork Canyon Creek with any deficiency in the available supply from East Fork Canyon Creek to be made up by diversion from Canyon Creek, a tributary of John Day River, for the PURPOSE of irrigation; that the PRIORITY OF THE RIGHT dates from October 28, 1982, and is limited to the amount of water which can be applied to beneficial use and shall not exceed 0.12 cubic foot per second measured at the points of diversion from the stream, or their equivalent in case of rotation with other water users.

The POINTS OF DIVERSION are to be LOCATED: Diversion 1 - 1,330 feet North and 2,280 feet West from the Southeast Corner of Section 19, being within the NW 1/4 SE 1/4 of Section 19; Diversion 2 - 550 feet South and 120 feet East from the Southeast Corner of Section 19, being within the NW 1/4 NW 1/4 of Section 29, both within Township 15 South, Range 32 East, WM, in the County of Grant.

A description of the PLACE OF USE under the permit, and to which such right is appurtenant, is as follows:

Township 15 South Range 32 East, WM Section 19 NW 1/4 SE 1/4 5.0 acres

The AMOUNT OF WATER used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to 1/40 of one cubic foot per second per acre, from direct flow and shall be further limited to a diversion of not to exceed 4.0 acre-feet per acre for each acre irrigated during the irrigation season of each year, and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

Actual construction work shall begin on or before January 7, 1984 and shall thereafter be prosecuted with reasonable diligence and be completed on or before October 1, 1984.

Complete application of the water to the proposed use shall be made on or before October 1, 1985.
