### PERMIT TO APPROPRIATE THE PUBLIC WATERS

This is to certify that I have examined APPLICATION 63961 and do hereby grant the same SUBJECT TO EXISTING RIGHTS INCLUDING THE APPROPRIATE MINIMUM FLOW POLICIES ESTABLISHED BY THE WATER POLICY REVIEW BOARD and the following limitations and conditions:

This permit is issued to Anadromous, Inc. of 203 South Columbia River Highway, St. Helens, Oregon 97051, phone 397-2121, for the use of the waters of Fort Creek, a tributary of Wood River, for the PURPOSE of fish culture (a project to rear juvenile salmon in concrete ponds); that the PRIORITY OF THE RIGHT dates from August 27, 1982, and is limited to the amount of water which can be applied to beneficial use and shall not exceed 44.7 cubic feet per second measured at the point of diversion from the stream, or its equivalent in case of rotation with other water users.

The POINT OF DIVERSION is to be LOCATED: 550 feet South and 810 feet East from the Northwest Corner of NE 1/4 SW 1/4 of Section 23, being within the NE 1/4 SW 1/4 of Section 23, Township 33 South, Range 7 1/2 East, WM, in the County of Klamath.

A description of the PLACE OF USE under the permit, and to which such right is appurtenant, is as follows:

Township 33 South Range 7 1/2 East, WM Section 23 NE 1/4 SW 1/4 Fish culture project to rear juvenile salmon in concrete ponds

The right granted herein shall be subject to the provisions of the Klamath Compact.

The right granted herein shall be subject to prior existing water rights.

The diversion of water from Fort Creek under the right granted herein shall be subject to maintaining no measurable difference between the rate of flow of the water being diverted from Fort Creek into the facilities of the permittee and the rate of flow of the water being discharged into Fort Creek from the said facilities of the permittee.

The right granted herein shall be subject to the terms and conditions of an easement executed by the applicant and recorded at page 1089, Volume 6 of the Miscellaneous Records of the Water Resources Department, and by reference made a part of this permit.

Actual construction work shall begin on or before January 3, 1984 and shall thereafter be prosecuted with reasonable diligence and be completed on or before October 1, 1984.

Complete application of the water to the proposed use shall be made on or before October 1, 1985.
