PERMIT TO APPROPRIATE THE PUBLIC WATERS

This is to certify that I have examined APPLICATION 63555 and do hereby grant the same SUBJECT TO EXISTING RIGHTS INCLUDING THE APPROPRIATE MINIMUM FLOW POLICIES ESTABLISHED BY THE WATER POLICY REVIEW BOARD and the following limitations and conditions:

This permit is issued to Eleviyn Seiders of Route 1, Box 21, Harper, Oregon 97906, phone 358-2715, for the use of the waters of two springs and a swamp area; being 0.11 cubic foot per second of water from each spring and 0.54 cfs from the swamp area, for the PURPOSE of irrigation and supplemental irrigation; that the PRIORITY OF THE RIGHT dates from May 21, 1982, and is limited to the amount of water which can be applied to beneficial use and shall not exceed 0.76 cfs measured at the points of diversion from the stream, or their equivalent in case of rotation with other water users.

The POINTS OF DIVERSION are to be LOCATED: Diversion 1 (Spring 1) - South 3 degrees 05 minutes West - 1,130 feet, being within the NE 1/4 NW 1/4 of Section 30; Diversion 2 (Spring 2) - South 15 degrees 40 minutes West - 1,021 feet, being within the NE 1/4 NW 1/4 of Section 30; Diversion 3 (Swamp area) - South 21 degrees 35 minutes West - 1,452 feet, being within the SE 1/4 NW 1/4 of Section 30, all from the N 1/4 Corner of Section 30, all being within Township 19 South, Range 43 East, WM, in the County of Malheur.

A description of the PLACE OF USE under the permit, and to which such right is appurtenant, is as follows:

Township 19 South Range 43 East, WM Section 30

Supplemental irrigation NE 1/4 NW 1/4 1.9 acres

The AMOUNT OF WATER used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to 1/40 of one cubic foot per second per acre, from direct flow and shall be further limited to a diversion of not to exceed 3.0 acre-feet per acre for each acre irrigated during the irrigation season of each year, provided further that the right allowed herein shall be limited to any deficiency in the available supply of any prior right existing for the same land and shall not exceed the limitation allowed herein, and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

Actual construction work shall begin on your before January 14, 1984 and shall thereafter be prosecuted with reasonable diligence and be completed on or before October 1, 1984.

Complete application of the water to the proposed use shall be made on or before October 1, 1985.
