**PERMIT TO APPROPRIATE THE PUBLIC WATERS**

This is to certify that I have examined APPLICATION 63577 and do hereby grant the same SUBJECT TO EXISTING RIGHTS INCLUDING THE APPROPRIATE MINIMUM FLOW POLICIES ESTABLISHED BY THE WATER POLICY REVIEW BOARD and the following limitations and conditions:

This permit is issued to Bill M. Lynn of Route 1, Box 108, Oakland, Oregon 97462, phone 459-3319, for the use of the waters of Calapooya Creek, a tributary of Umpqua River, for the PURPOSE of irrigation and livestock use; being 0.24 cubic foot per second of water for irrigation and 0.005 cfs for livestock use; that the PRIORITY OF THE RIGHT dates from May 25, 1982, and is limited to the amount of water which can be applied to beneficial use and shall not exceed 0.245 cfs measured at the point of diversion from the stream, or its equivalent in case of rotation with other water users.

The POINT OF DIVERSION is to be LOCATED: 1,200 feet South and 700 feet West from the Northeast Corner of Section 7, being within the NE 1/4 NE 1/4 of Section 7, Township 25 South, Range 4 West, WM, in the County of Douglas.

A description of the PLACE OF USE under the permit, and to which such right is appurtenant, is as follows:

Township 25 South	Range 4 West, WM	Section 7	NE 1/4	NE 1/4	14.0 acres and live- stock use
			SE 1/4	NE 1/4	5.0 acres and live- stock use

The AMOUNT OF WATER used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to 1/80 of one cubic foot per second per acre, from direct flow and shall be further limited to a diversion of not to exceed 2.5 acre-feet per acre for each acre irrigated during the irrigation season of each year, and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

Actual construction work shall begin on your before January 14, 1984 and shall thereafter be prosecuted with reasonable diligence and be completed on or before October 1, 1984.

Complete application of the water to the proposed use shall be made on or before October 1, 1985.
