PERMIT TO APPROPRIATE THE PUBLIC WATERS

This is to certify that I have examined APPLICATION **58595** and do hereby grant the same SUBJECT TO EXISTING RIGHTS INCLUDING THE APPROPRIATE MINIMUM FLOW POLICIES ESTABLISHED BY THE WATER POLICY REVIEW BOARD and the following limitations and conditions:

This permit is issued to Oregon Department of Fish and Wildlife of 506 SW Mill Street, Portland, Oregon 97201, phone 229-5701, for the use of the waters of Fern Ridge Reservoir constructed under Permit R-1625 and Cleary Creek Reservoir to be constructed under Application* for the PURPOSE of irrigation,

that the PRIORITY OF THE RIGHT dates from November 20, 1981,

and is limited to the amount of water which can be applied to beneficial use and shall not exceed 559.0 acre-feet stored water only.

The POINT OF DIVERSION is to be LOCATED: Diversion 1 - 3,700 feet North and 3,970 feet West from the Southeast Corner of Section 35, being within the SW 1/4 NW 1/4 of Section 35; Diversion 2 - 3,000 feet North and 650 feet West from the Southeast Corner of Section 35, being within the SE 1/4 NE 1/4 of Section 35; Diversion 3 - 2,800 feet North and 1,250 feet West from the Southeast Corner of Section 34, being within the SE 1/4 NE 1/4 of Section 34, all being**

Complete application of the water to the proposed use shall be made on or before October 1, 1985.

The AMOUNT OF WATER used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to a diversion of not to exceed 2.5 acre-feet per acre for each acre irrigated during the irrigation season of each year from direct flow and storage of water from reservoir constructed under Permit R-1625 and a reservoir to be constructed under Permit R-8548, provided further that the right allowed herein shall be limited to any deficiency in the available supply of any prior right existing for the same land and shall not exceed the limitation allowed herein, and is subject to the terms and conditions of Contract I-07-10-W0414 between the Bureau of Reclamation and the applicant, or a satisfactory replacement, a copy of which is on file in the records of the Water Resources Director.
