PERMIT TO APPROPRIATE THE PUBLIC WATERS

This is to certify that I have examined APPLICATION 62607 and do hereby grant the same SUBJECT TO EXISTING RIGHTS INCLUDING THE APPROPRIATE MINIMUM FLOW POLICIES ESTABLISHED BY THE WATER POLICY REVIEW BOARD and the following limitations and conditions:

This permit is issued to Alvin E. Reese of 194 East Willis Creek, Winston, Oregon 97496, phone 679-8591, for the use of the waters of Willis Creek, a tributary of South Umpqua River,

for the PURPOSE of irrigation, stock and domestic use for one family; being 0.13 cubic foot per second for irrigation, 0.005 cfs for stock, and 0.005 cfs for domestic use,

that the PRIORITY OF THE RIGHT dates from December 20, 1982,

and is limited to the amount of water which can be applied to beneficial use and shall not exceed 0.14 cubic foot per second.

The POINT OF DIVERSION is to be LOCATED: 1,180 feet South and 600 feet East from the Northwest Corner of Section 15, being within NW 1/4 NW 1/4 of Section 15, Township 29 South, Range 6 West, WM, in the County of Douglas.

A description of the PLACE OF USE under the permit, and to which such right is appurtenant, is as follows:

Township 29 South, Range 6 West, WM Section 15 NW 1/4 NW 1/4 10.0 acres irrigation stock use and domestic use for one family

The AMOUNT OF WATER used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to 1/80 of one cubic foot per second per acre, from direct flow and shall be further limited to a diversion of not to exceed 2.5 acre-feet per acre for each acre irrigated during the irrigation season of each year, and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

Actual construction work shall begin on or before February 14, 1984, and shall thereafter be prosecuted with reasonable diligence and be completed on or before October 1, 1984.

Complete application of the water to the proposed use shall be made on or before October 1, 1985.
