### PERMIT TO APPROPRIATE THE PUBLIC WATERS

This is to certify that I have examined APPLICATION **63615** and do hereby grant the same SUBJECT TO EXISTING RIGHTS INCLUDING THE APPROPRIATE MINIMUM FLOW POLICIES ESTABLISHED BY THE WATER POLICY REVIEW BOARD and the following limitations and conditions:

This permit is issued to **Everett O. Worley of Box 174, Azalea, Oregon 97410, phone 837-3584, for the use of the waters of Cow Creek, a tributary of South Umpqua River,**

for the PURPOSE of **irrigation,**

that the PRIORITY OF THE RIGHT dates from **June 11, 1982 for 0.24 cubic foot per second and December 16, 1982 for 0.05 cfs,**

and is limited to the amount of water which can be applied to beneficial use and shall not exceed **0.29 cubic foot per second.**

The POINT OF DIVERSION is to be LOCATED: **830 feet South and 350 feet East from the N 1/4 Corner of Section 7, being within the NW 1/4 NE 1/4 of Section 7, Township 32 South, Range 4 West, WM, in the County of Douglas.**

A description of the PLACE OF USE under the permit, and to which such right is appurtenant, is as follows:

Township 32 South, Range 4 West, WM	Section 7	NW 1/4	NE 1/4	2.5 acres
		SW 1/4	NE 1/4	17.5 acres

The AMOUNT OF WATER used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to 1/70 of one cubic foot per second per acre, from direct flow and shall be further limited to a diversion of not to exceed 3.5 acre-feet per acre for each acre irrigated during the irrigation season of each year, and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

Actual construction work shall begin on or before **February 14, 1984**, and shall thereafter be prosecuted with reasonable diligence and be completed on or before October 1, 19 **84**.

Complete application of the water to the proposed use shall be made on or before October 1, 19 **85**.
