PERMIT TO APPROPRIATE THE PUBLIC WATERS

This is to certify that I have examined APPLICATION 64545 and do hereby grant the same SUBJECT TO EXISTING RIGHTS INCLUDING THE APPROPRIATE MINIMUM FLOW POLICIES ESTABLISHED BY THE WATER POLICY REVIEW BOARD and the following limitations and conditions:

This permit is issued to Larry R. Furrer of Star Route, Box 189-10, Umpqua, Oregon 97486, phone 459-4318, for the use of the waters of Umpqua River, a tributary of Pacific Ocean,

for the PURPOSE of $\$ irrigation and stock use, being 0.10 cubic foot per second of water for irrigation and 0.005 cfs for stock,

that the PRIORITY OF THE RIGHT dates from November 22, 1982,

and is limited to the amount of water which can be applied to beneficial use and shall not exceed 0.105 cubic foot per second.

The POINT OF DIVERSION is to be LOCATED: 2,148 feet South and 1,140 feet West from the Northeast Corner of Section 31, being within the SE 1/4 NE 1/4 of Section 31, Township 24 South, Range 7 West, WM, in the County of Douglas.

A description of the PLACE OF USE under the permit, and to which such right is appurtenant, is as follows:

Township 24 South, Range 7 West, WM

Section 31 SE 1/4 NE 1/4

5.94 acres and stock

Section 32 SW 1/4 NW 1/4 1.82 acres

The AMOUNT OF WATER used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to 1/80 of one cubic foot per second per acre, from direct flow and shall be further limited to a diversion of not to exceed 2.5 acre-feet per acre for each acre irrigated during the irrigation season of each year, and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

Actual construction work shall begin on or before February 23, 1984 reasonable diligence and be completed on or before October 1, 19 84 .

Complete application of the water to the proposed use shall be made on or before October 1, 19 85.
