PERMIT TO APPROPRIATE THE PUBLIC WATERS

This is to certify that I have examined APPLICATION **63280** and do hereby grant the same SUBJECT TO EXISTING RIGHTS INCLUDING THE APPROPRIATE MINIMUM FLOW POLICIES ESTABLISHED BY THE WATER POLICY REVIEW BOARD and the following limitations and conditions:

This permit is issued to **James A. Flowers of PO Box 96, Midland, Oregon 97634, phone 882-1323, for the use of the waters of Klamath River via ADY Intake Channel,**

for the PURPOSE of **Irrigation,**

that the PRIORITY OF THE RIGHT dates from **February 22, 1982,**

and is limited to the amount of water which can be applied to beneficial use and shall not exceed **1.91 cubic feet per second.**

The POINT OF DIVERSION is to be LOCATED: **Diversion 1 - 200 feet South and 1,390 feet East from the Northwest Corner of Section 23, being within the NW 1/4 NW 1/4 of Section 23; Diversion 2 - 750 feet North and 950 feet West from the Southeast Corner of Section 15, being within the SE 1/4 SE 1/4 of Section 15, both within Township 40 South, Range 8 East, WM, in the County of Klamath.**

A description of the PLACE OF USE under the permit, and to which such right is appurtenant, is as follows:

The AMOUNT OF WATER used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to 1/40 of one cubic foot per second per acre, from direct flow and shall be further limited to a diversion of not to exceed 3.0 acre-feet per acre for each acre irrigated during the irrigation season of each year, and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

Actual construction work shall begin on or before **March 14, 1984** and shall thereafter be prosecuted with reasonable diligence and be completed on or before October 1, 19**84**.

Complete application of the water to the proposed use shall be made on or before October 1, 19**85**.
