## PERMIT TO APPROPRIATE THE PUBLIC WATERS

This is to certify that I have examined APPLICATION **63505** and do hereby grant the same SUBJECT TO EXISTING RIGHTS INCLUDING THE APPROPRIATE MINIMUM FLOW POLICIES ESTABLISHED BY THE WATER POLICY REVIEW BOARD and the following limitations and conditions:

This permit is issued to **Jason C. Reynolds of 4705 Highway 34, Waldport, Oregon 97394, phone 528-3050, for the use of the waters of an unnamed creek, a tributary of Alsea River,**

for the PURPOSE of **irrigation and supplemental supply for domestic use for two families, being 0.06 cubic foot per second of water for irrigation and 0.01 cfs for domestic use,**

that the PRIORITY OF THE RIGHT dates from **May 3, 1982,**

and is limited to the amount of water which can be applied to beneficial use and shall not exceed **0.07 cubic foot per second.**

The POINT OF DIVERSION is to be LOCATED: **94 feet South and 102 feet West from the SW 1/16 Corner of Section 28, being within the SW 1/4 SW 1/4 of Section 28, Township 13 South, Range 10 West, WM, in the County of Lincoln.**

A description of the PLACE OF USE under the permit, and to which such right is appurtenant, is as follows:

**Township 13 South, Range 10 West, WM Section 28 Lot 12 (SW 1/4 SW 1/4) Domestic use for two families and 4.5 acres irrigation**

The AMOUNT OF WATER used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to 1/80 of one cubic foot per second per acre, from direct flow and shall be further limited to a diversion of not to exceed 2.5 acre-feet per acre for each acre irrigated during the irrigation season of each year, and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

Actual construction work shall begin on or before **March 14, 1984** and shall thereafter be prosecuted with reasonable diligence and be completed on or before October 1, 19**84** Extended to Oct. 1985

Complete application of the water to the proposed use shall be made on or before October 1, 19**85** Extended to Oct. 1, 1986
