PERMIT TO APPROPRIATE THE PUBLIC WATERS

This is to certify that I have examined APPLICATION **63767** and do hereby grant the same SUBJECT TO EXISTING RIGHTS INCLUDING THE APPROPRIATE MINIMUM FLOW POLICIES ESTABLISHED BY THE WATER POLICY REVIEW BOARD and the following limitations and conditions:

This permit is issued to **Nick C. Weber of 12799 Lower Graves Creek Road, Wolf Creek, Oregon 97497, for the use of the waters of #1 Creek and a spring, being 0.095 cubic foot per second of water from #1 Creek and 0.003 cfs from the spring, tributaries of Grave Creek,** for the PURPOSE of **irrigation, supplemental irrigation, and domestic use for two families, being 0.09 cfs from #1 Creek for irrigation and supplemental irrigation, 0.005 cfs from #1 Creek for domestic use for one family, 0.003 cfs from the spring for irrigation, and 0.003 cfs from the*** that the PRIORITY OF THE RIGHT dates from **July 15, 1982,**

***spring for domestic use for one family,**

and is limited to the amount of water which can be applied to beneficial use and shall not exceed **0.098 cubic foot per second.**

The POINT OF DIVERSION is to be LOCATED: **Diversion 1 (#1 Creek) - 50 feet South and 920 feet East from the W 1/4 Corner of Section 32, being within the NW 1/4 SW 1/4 of Section 32; Diversion 2 (Spring) - 1,050 feet North and 100 feet West from the Southeast Corner of SW 1/4 SW 1/4 of Section 32, being within the SW 1/4 SW 1/4 of Section 32, both being within Township 33 South, Range 7 West, WM, in the County of Jackson.**

A description of the PLACE OF USE under the permit, and to which such right is appurtenant, is as follows:

The AMOUNT OF WATER used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to 1/80 of one cubic foot per second per acre, from direct flow and shall be further limited to a diversion of not to exceed 4.5 acre-feet per acre for each acre irrigated during the irrigation season of each year, provided further that the right allowed herein shall be limited to any deficiency in the available supply of any prior right existing for the same land and shall not exceed the limitation allowed herein, and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

Actual construction work shall begin on or before **March 14, 1984**, and shall thereafter be prosecuted with reasonable diligence and be completed on or before October 1, 19 **84**.

Complete application of the water to the proposed use shall be made on or before October 1, 19 **85**.
