PERMIT TO APPROPRIATE THE PUBLIC WATERS

This is to certify that I have examined APPLICATION 64600 and do hereby grant the same SUBJECT TO EXISTING RIGHTS INCLUDING THE APPROPRIATE MINIMUM FLOW POLICIES ESTABLISHED BY THE WATER POLICY REVIEW BOARD and the following limitations and conditions:

This permit is issued to James Pierce Petitti of 17610 Shady Lane, Monmouth, Oregon 97361, phone 838-6405, for the use of the waters of an unnamed drainageway, five springs, and a reservoir to be constructed under Application R-64599, Permit R-8595; being 8.0 galions per minute from* for the PURPOSE of domestic use for two families, irrigation and maintenance of reservoir for fish culture; being 2.0 gpm from Spring AA for domestic use for two families, 2.0 gpm from Spring AA, 1.5 gpm from Spring BB, 2.0 gpm from Spring CC, 3.0 gpm from Spring DD, and 2.0 gpm** that the PRIORITY OF THE RIGHT dates from December 28, 1982,

and is limited to the amount of water which can be applied to beneficial use and shall not exceed 19.5 gallons per min-

The POINT OF DIVERSION is to be LOCATED: Diversion 1 (Spring AA) - 1,414 feet South and 384 feet East from the N 1/4 Corner of Section 14, being within the SW 1/4 NE 1/4 of Section 14; Diversion 2 (Spring BB) - 964 feet South and 135 feet East from the N 1/4 Corner of Section 14, being within the NW 1/4 NE 1/4 of Section 14; Diversion 3 (Spring CC) - 1,325 feet South and 217 feet West from the N 1/4 Corner of Section 14, being within the SE 1/4 NW 1/4 of Section 14;***

The AMOUNT OF WATER used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to 1/80 of one cubic foot per second per acre, from direct flow and shall be further limited to a diversion of not to exceed 2.5 acre-feet per acre for each acre irrigated during the irrigation season of each year, provided further that the total quantity of water diverted from all sources shall not exceed 19.5 gpm, and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

*unnamed drainageway, 2.0 gpm from Spring AA, 1.5 gpm from Spring BB, 3.0 gpm from Spring CC, 3.0 gpm from Spring DD, and 2.0 gpm from Spring EE,

**from Spring EE for irrigation, and 8.0 gpm from unnamed drainageway with any deficiency in the supply of water available from the drainageway to be made up by diversion from Springs AA, CC, and DD for maintenance of reservoir for fish culture,

***Diversion 4 (Spring DD) - 1,493 feet South and 451 feet West from the N 1/4 Corner of Section 14, being within the SE 1/4 NW 1/4 of Section 14; Diversion 5 (Spring EE) - 1,564 feet South and 911 feet West from the N 1/4 Corner of Section 14, being within the SE 1/4 NW 1/4 of Section 14; Diversion 6 (Reservoir) - 1,200 feet South and 250 feet West from the N 1/4 Corner of Section 14, being within the NE 1/4 NW 1/4 of Section 14, all within Township 9 South, Range 6 West, WM, in the County of Polk.
