## PERMIT TO APPROPRIATE THE PUBLIC WATERS

This is to certify that I have examined APPLICATION **64573** and do hereby grant the same SUBJECT TO EXISTING RIGHTS INCLUDING THE APPROPRIATE MINIMUM FLOW POLICIES ESTABLISHED BY THE WATER POLICY REVIEW BOARD and the following limitations and conditions:

This permit is issued to **Albert C. Schattenkerk of Star Route, Box 15, Winston, Oregon 97496, phone 679-6111, for the use of the waters of Brockway Creek, an unnamed stream, two unnamed springs, and four reservoirs to be constructed under Application R-64572, Permit R-8597,\*** for the PURPOSE of **irrigation,**

that the PRIORITY OF THE RIGHT dates from **December 7, 1982,**

and is limited to the amount of water which can be applied to beneficial use and shall not exceed **0.47 cubic feet per second.**

The POINT OF DIVERSION is to be LOCATED: **Diversion 1 (Brockway Creek) - 1,730 feet North and 1,530 feet West from the Southeast Corner of Section 25, being within the NW 1/4 SE 1/4 of Section 25; Diversion 2 (Unnamed Stream) - 2,400 feet North and 2,170 feet West from the Southeast Corner of Section 25, being within the NW 1/4 SE 1/4 of\*\***

A description of the PLACE OF USE under the permit, and to which such right is appurtenant, is as follows:

The AMOUNT OF WATER used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to 1/80 of one cubic foot per second per acre, from direct flow and shall be further limited to a diversion of not to exceed 2.5 acre-feet per acre for each acre irrigated during the irrigation season of each year from direct flow and storage from reservoir to be constructed under Permit R-8597, and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

Actual construction work shall begin on or before **March 22, 1984**, and shall thereafter be prosecuted with reasonable diligence and be completed on or before October 1, 19 **84**.

Complete application of the water to the proposed use shall be made on or before October 1, 19 **85**.

\*\*Section 25; Diversion 3 (Spring 1) - 2,560 feet North and 2,080 feet West from the Southeast Corner of Section 25, being within the NW 1/4 SE 1/4 of Section 25; Diversion 4 (Spring 2) - 2,600 feet North and 370 feet West from the Southeast Corner of Section 25, being within the NE 1/4 SE 1/4 of Section 25, all within Township 28 South, Range 7 West, WM, in the County of Douglas.
