## PERMIT TO APPROPRIATE THE PUBLIC WATERS

This is to certify that I have examined APPLICATION 60126 and do hereby grant the same SUBJECT TO EXISTING RIGHTS INCLUDING THE APPROPRIATE MINIMUM FLOW POLICIES ESTABLISHED BY THE WATER POLICY REVIEW BOARD and the following limitations and conditions:

This permit is issued to George A. and Julia E. Gatchel of Star Route, Cavitt Creek Road, Glide, Oregon 97443, phone 496-3263, for the use of the waters of McKay Creek and a reservoir to be constructed under Application R-60125, Permit R-8598, tributary of Cavitt Creek, for the PURPOSE of irrigation and fish culture; being 0.06 cubic foot per second for irrigation and 0.005 cfs for maintenance of reservoir for fish culture

that the PRIORITY OF THE RIGHT dates from January 3, 1983,

and is limited to the amount of water which can be applied to beneficial use and shall not exceed 0.065 cubic foot per second.

The POINT OF DIVERSION is to be LOCATED: Dam - 1,300 feet South and 1,810 feet East from the Northwest Corner of Section 23, being within the NE 1/4 NW 1/4 of Section 23; Pond - 1,470 feet South and 2,370 feet East from Northwest Corner, Section 23, being within SE 1/4 NW 1/4 of Section 23, both within the Township 27 South, Range 3 West, WM, in the County of Douglas.

A description of the PLACE OF USE under the permit, and to which such right is appurtenant, is as follows:

Township 27 South, Range 3 West, WM Section 23 SE 1/4 NW 1/4 5.0 acres and fish pond

The AMOUNT OF WATER used for irrigation, together with the amount secured under any other right existing for the same lands shall be limited to 1/80 of one cubic foot per second per acre, and shall be further limited to a diversion of not to exceed 2.5 acre-feet per acre for each acre irrigated during the irrigation season of each year from direct flow and storage from reservoir to be constructed under Permit 8598.

Actual construction work shall begin on or before April 15, 1984, and shall thereafter be prosecuted with reasonable diligence and be completed on or before October 1, 1985.

Complete application of the water to the proposed use shall be made on or before October 1, 1986.
