irrigation and flood harvesting of cranberries, being 0.023 cfs from Stream 1 for the PURPOSE of 1871 and 1880 harvesting of Cranberries, being 0.023 cis from Stream for irrigation and 0.045 cfs from Stream 1 for flood harvesting, 0.031 cfs from Stream 2 for irrigation and 0.061 cfs from Stream 2 for flood harvesting,

that the PRIORITY OF THE RIGHT dates from February 22, 1983,

limitations and conditions:

and is limited to the amount of water which can be applied to beneficial use and shall not exceed second.

Diversion 1 - 60 feet South and 2,100 feet West from the The POINT OF DIVERSION is to be LOCATED: Diversion 1 - 60 feet South and 2,100 feet west from the Northeast Corner of Section 28, being within NW 1/4 NE 1/4 of Section 28; Diversion 2 - 2,340 feet South and 330 feet West from the Northeast Corner of Section 28, being within the SE 1/4 NE 1/4 of Section 28, Township 28 South, Range 14 West, WM, in the County of Coos.

A description of the PLACE OF USE under the permit, and to which such right is appurtenant, is as follows: Unnamed Stream 1 Township 28 South, Range 14 West, WM Section 28 SE 1/4 NE 1/4 0.9 acre cranberry irrigation and flood harvest

> Unnamed Stream 2 NE 1/4 1.22 acres cranberry ir-SE 1/4 rigation and flood harvest

If for irrigation, this appropriation shall be limited to 1/40 of one cubic foot per second of its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 3.0 acre-feet per acre for each acre irrigated during the irrigation season of each year, for cranberries. If for the irrigation of any other crop, this appropriation shall be limited to 1/80 of one cubic foot per second or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2.5 acre-feet per acre for each acre irrigated during the irrigation season of each year, and shall conform to such reasonable rotation system as may be ordered by the proper state officer.
